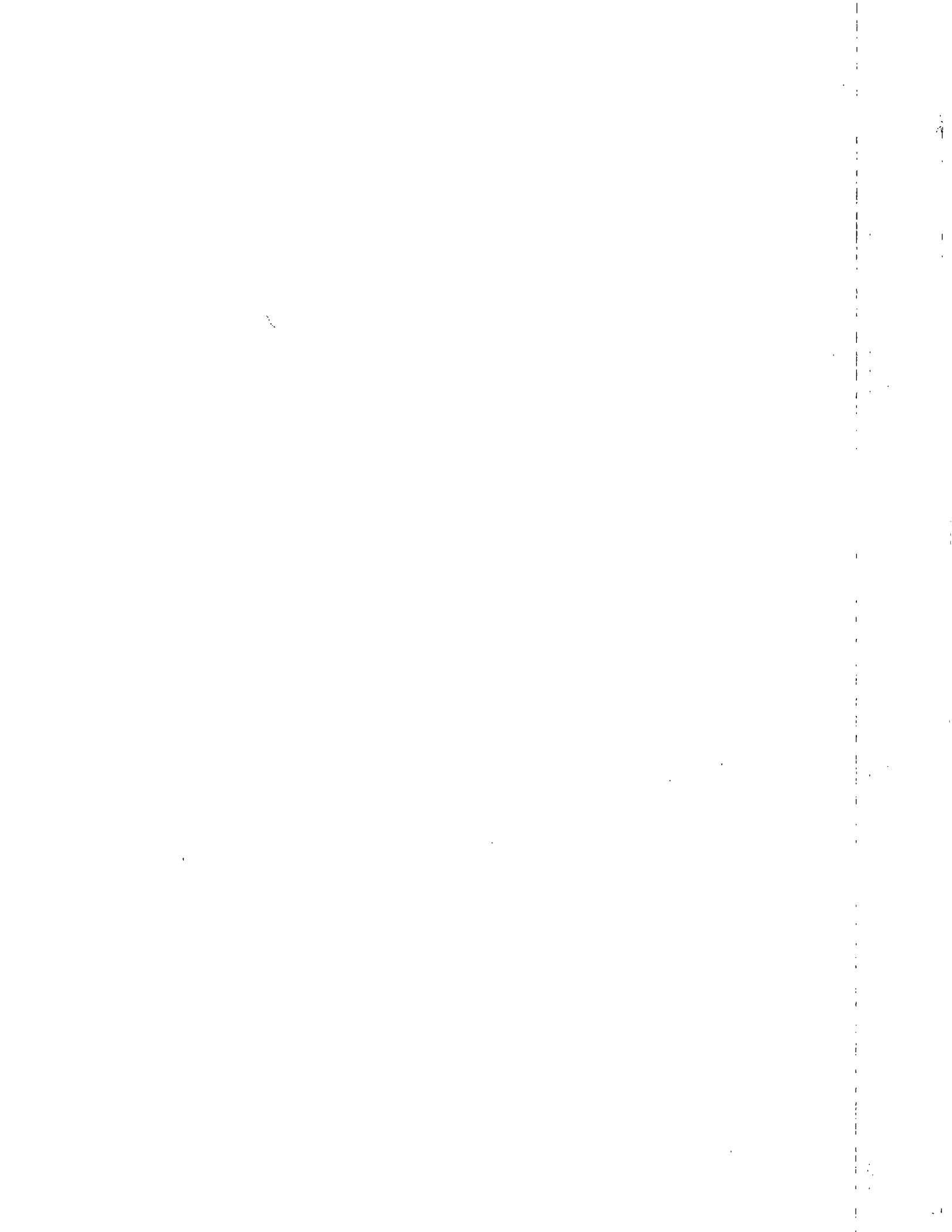

ORDINANCE
JEFFERSON TAP AND GRILLE AND THE LOFT
Acct. No. 64048 - 3
Permit No. 1103635

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to JEFFERSON TAP AND GRILLE AND THE LOFT, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, Occupation of Space for (two Dumpsters) on the public right-of-way adjacent to its premises known as 323-325 N. Jefferson St..

Said Occupation of Space(s) at N. Jefferson measure(s):

Two (2) at six point six seven (6.67) feet in length, and four (4) feet in width for a total of fifty-three point three six (53.36) square feet. Existing dumpsters is used for a refuse container and grease container.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1103635 herein granted the sum of eight hundred (\$800.00) per annum in advance.

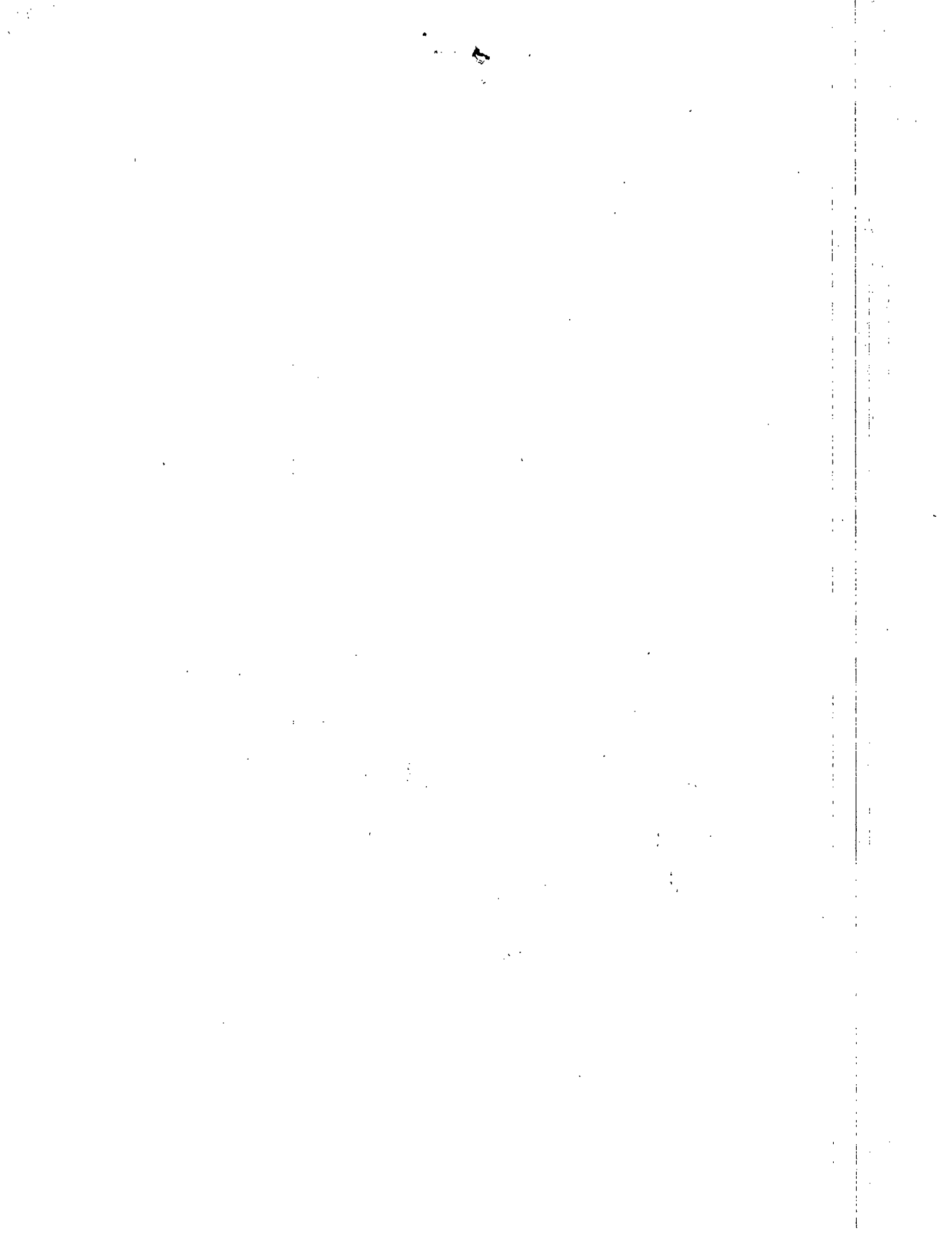
A 25% penalty will be added for payments received after due date.

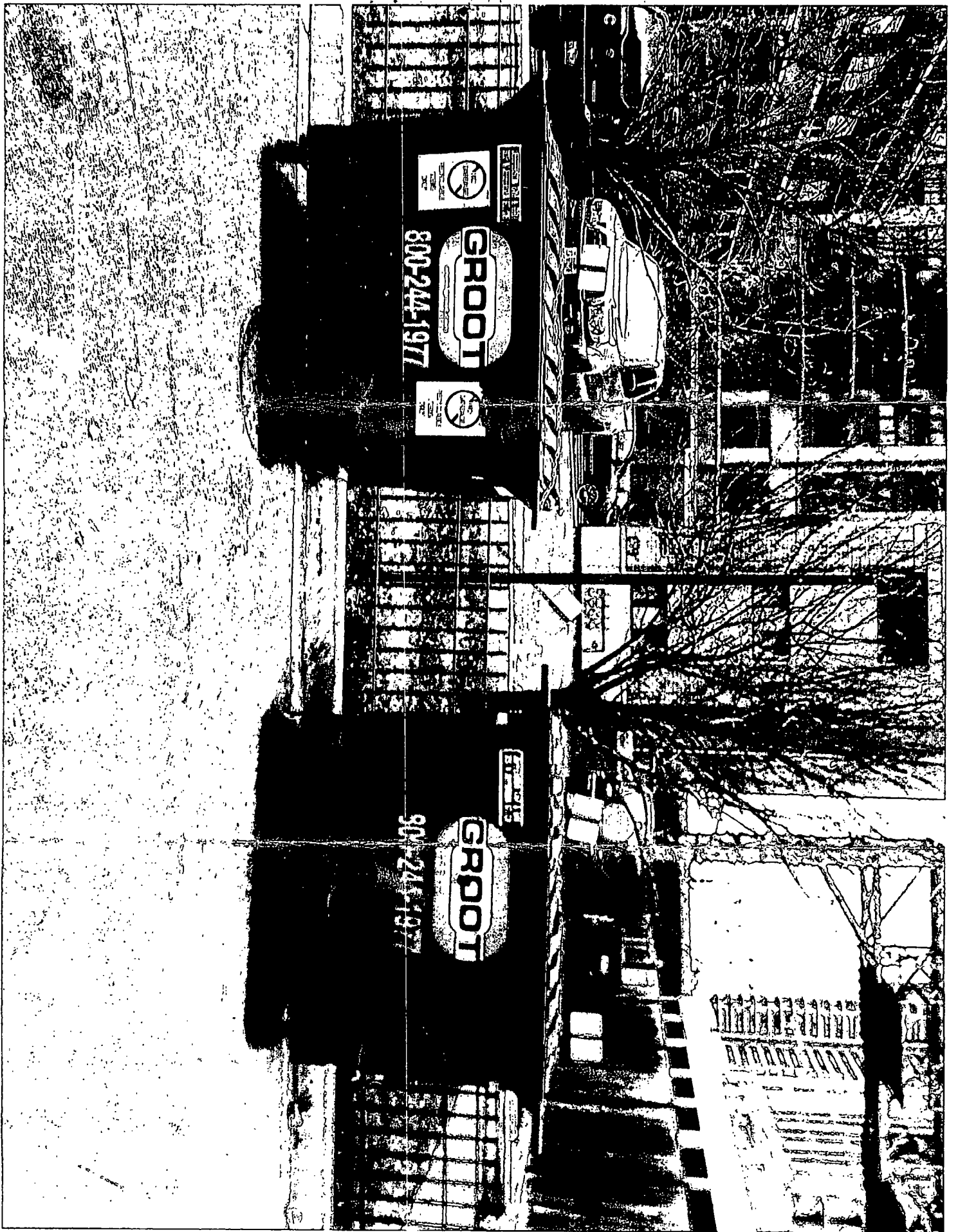

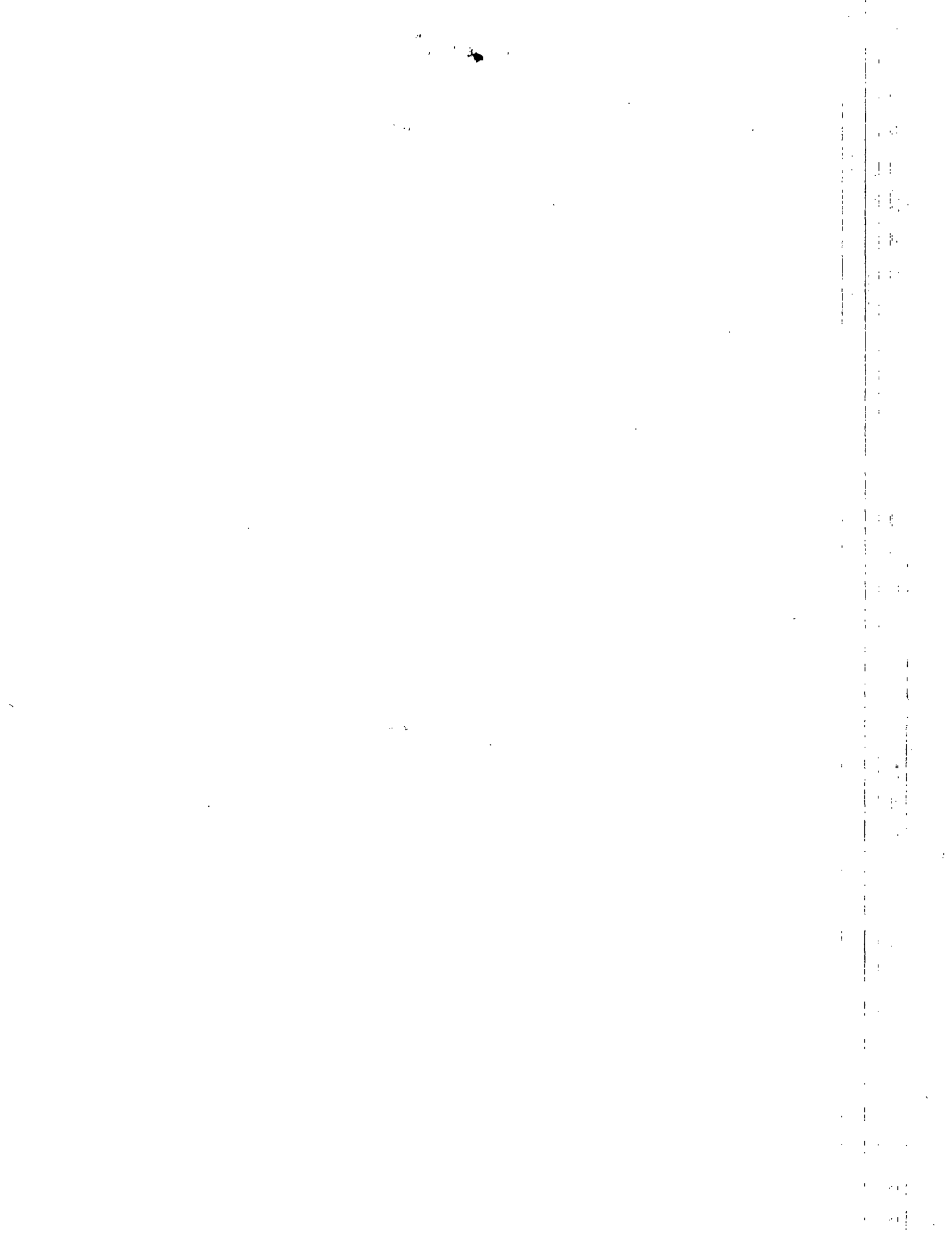
