BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No.8-F in the area bounded by

a line 37 feet north of and parallel to West 33rd Street;
the alley next east of and parallel to South Halsted Street;
West 33rd Street; and South Halsted Street,

to those of a C1-3 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


Approximately 2,600 square feet of the ground floor of the Property is currently used for the restaurant known as "Nana." Nana is a table service restaurant specializing in delicious organic food, which is free from hormones, antibiotics, pesticides and other additives. Nana has been featured on local and national television shows such as WTTW's "Check Please" and The Food Network's "Diners, Drive-Ins and Dives." Currently, it is one of the most popular restaurants in Bridgeport.

Nana currently serves alcoholic beverages, which are incidental to the consumption of food. However, the Applicant seeks to create an upscale lounge on the property in approximately 2000 square feet of existing rough space located behind Nana. The proposed lounge would primarily serve alcohol but also serve food, such as appetizers that would be prepared in Nana's kitchen. The Applicant needs the proposed zoning before it seeks to obtain a tavern license. The proposed lounge space would be approximately 2000 square feet. The building height is approximately twenty-five (25) feet. Currently, there are three (3) apartments located on the second floor of the building. One of the apartments is currently occupied by one of the owners of the Applicant, AIRAM, INC.
