BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Single-Unit Detached House District symbols and indications as shown on Map No. 26-E in the area bounded by

East 103rd Street; South Rhodes; the public alley next south of and parallel to East 103rd Street; a line 83.52 feet west of and parallel to South Rhodes Avenue (said line being perpendicular to East 103rd Street)

to those of a B1-1 Neighborhood Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.



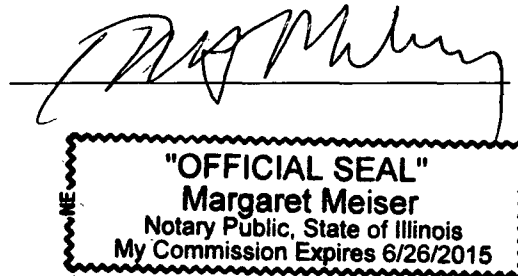

In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about July 18, 2012, I, the undersigned, will file an application for a change in zoning from an RS-3 Single-Unit Detached House District to a B1-1 Neighborhood Shopping District on behalf of 103rd St. Building LLC, owner of the property located at 519-25 East 103rd Street.
