BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS2 Residential Single–Unit (Detached House) District symbols as shown on Map No. 12-M in the area bounded by:

A line 283 feet South of and parallel to West 53rd Street; South Monitor Avenue; a line 316 feet South of and parallel to West 53rd Street; a public alley next West of and parallel to South Monitor Avenue.

To those of an RT3.5, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and approval.

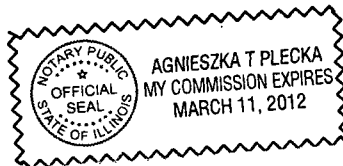

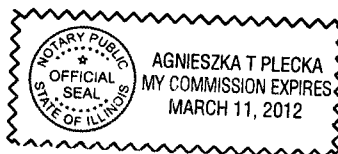

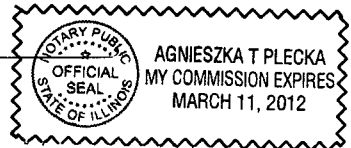
