William was Secretary Treasurer to the late Congressman/Alderman Roman Pucinski and to Justice Aurelia Pucinski later joining the 45th Ward Democratic organization. He was a retired Local 399 Assistant Chief Operating Engineer for the City of Chicago at O'Hare Airport for thirty three years. In addition to his love for politics, William was also passionate about sports and spent most of his life inspiring athletes to love the sport of soccer by coaching and refereeing. William will be deeply missed but the memory of his character, intelligence, and compassion will live on in those who knew and loved him; now, therefore
