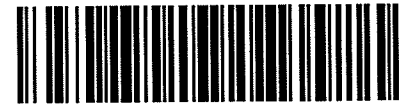



ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1. Pursuant to an ordinance passed by the City Council on December 3, 1984 and appearing in the Journal of Proceedings of that date at pages 11459 through 11460, allowing the erection of honorary street-name signs, the Commissioner of Transportation is hereby authorized to take any necessary action to standardize East 58th Street, from South Maryland Avenue to South Drexel Avenue, as honorary Dr. Donald Chua Liu Way.

Section 2. This ordinance shall take effect upon its passage and approval.
