**SUBSTITUTE ORDINANCE**

WHEREAS, the Annual Appropriation Ordinance for the year 2012 of the City of Chicago (the "City") contains estimates of revenues receivable as grants from agencies of the state and federal governments and public and private agencies; and

WHEREAS, in accordance with Section 8 of the Annual Appropriation Ordinance, the heads of various departments and agencies of the City have applied to agencies of the state and federal governments and public and private agencies for grants to the City for various purposes; and

WHEREAS, the City through its Department of Public Health ("CDPH") has been awarded additional private grant funds in the amount of \$317,000 by Blue Cross Blue Shield of Illinois, which shall be used for the Care Van program; and

WHEREAS, the City through CDPH has been awarded additional private grant funds in the amount of \$88,000 by the University of Chicago, which shall be used for the Diabetes Translational Research Program; and

WHEREAS, the City through its Department of Housing and Economic Development has been awarded additional federal grant funds in the amount of \$750,000 by the U.S. Department of Energy, which shall be used for the SunShot Rooftop Solar Challenge Program; and

WHEREAS, the City through its Department of Transportation ("CDOT") has been awarded additional federal grant funds in the amount of \$6,500,000 by a sub-grant from the Chicago Transit Authority of Federal Transit Administration funds, which shall be used for the Jeffery Bus Rapid Transit project; and

WHEREAS, the City, through CDOT, has been awarded additional federal grant funds in the amount of \$30,000 by the Fish and Wildlife Service of the U.S. Department of the Interior, which shall be used to raise public awareness of migratory bird habitats in Chicago; now, therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. The sum of \$7,615,000 not previously appropriated is hereby appropriated from Fund 925 - Grant Funds for the year 2012. The Annual Appropriation Ordinance is hereby amended by striking the words and figures and adding the words and figures indicated in the attached Exhibit A which is hereby made a part hereof.

SECTION 2. Those certain funds appropriated in the amount of \$650,000 pursuant to an Ordinance of the City Council of the City that was adopted on November 9, 2011 and set forth in the Journal of Proceedings thereof at pages 12488 to 12490 for such date, for the City's Department of Family and Support Services to be used for Low Income Home Energy Assistance Program (LIHEAP) Matching Grants, is hereby re-appropriated to the City's Department of Fleet and Facility Management to be used for the Share the Warmth Program.

SECTION 3. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 4. This ordinance shall be in full force and effect upon its passage and approval.


CHICAGO, February 15, 2012
