Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to LUXE A SALON INC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, four (4) Banner(s) projecting over the public right-of-way adjacent to its premises known as 2109 W. Belmont Ave..

One (1) at two (2) feet in length, and four (4) feet in width for a total of eight (8) square feet.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1107299 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

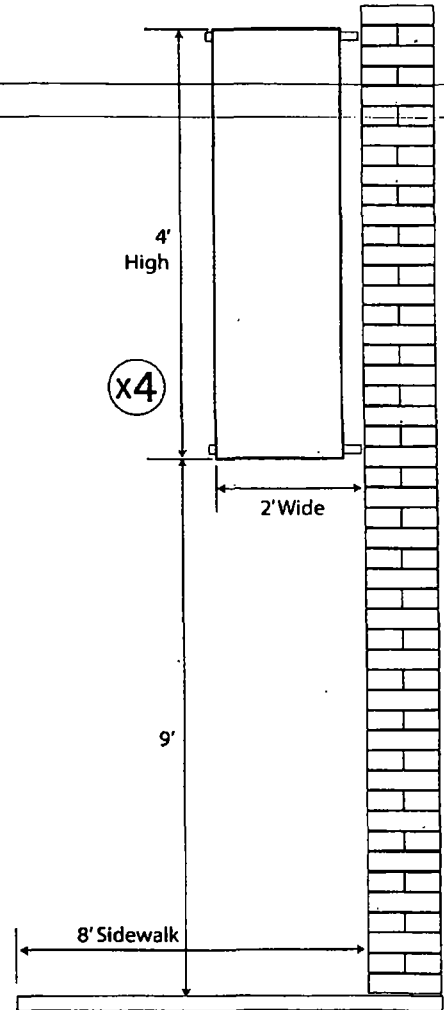
