**ORDINANCE**

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-1 Neighborhood Shopping District and M1-1 Limited Manufacturing/Business Park District symbols and indications as shown on Map No.7-N in the area bounded by

a line 196 feet north of and parallel to West Wrightwood Avenue;  
the alley next east of and parallel to North Harlem Avenue; West  
Wrightwood Avenue; and North Harlem Avenue (City Limits),

to those of a B2-2 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.
