COMMERCIAL VACATION ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 Constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the properties at 1601-1617 W. Walnut Street, 212-222 N. Ashland Avenue, 200-208 N. Ashland Avenue, and 1600-1624 W. Lake Street Avenue are owned by Ashland Lake LLC ("Developer"); and

WHEREAS, the properties at 1621-1627 W. Walnut Street and 1626-1628 W. Lake Street are owned by Walnut Paulina LLC, which has quit claimed any and all of its interests in the public alleys herein vacated, to the Developer; and

WHEREAS, the Developer proposes to use the portion of the alleys to be vacated herein for a driveway to serve its adjacent buildings; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of that portion of the public alleys, described in the following ordinance; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1.

VACATION OF:

THAT PART OF THE EAST-WEST 16 FOOT WIDE PUBLIC ALLEY LYING SOUTH OF AND ADJOINING THE SOUTH LINE OF LOTS 4,3, AND THAT PART OF LOT 2; LYING WEST OF AND ADJOINING THE SOUTHERN EXTENSION OF THE EAST LINE OF SAID LOT 4 TO THE NORTHEAST CORNER OF SAID LOT 8 AND LYING EAST OF AND ADJOINING THE EASTERLY TERMINUS OF PREVIOUSLY VACATED SAID ALLEY AS VACATED BY ORDINANCE RECORDED JANUARY 3, 1980 (79-579) AS DOCUMENT NUMBER 93-422169, ALL INCLUSIVE IN LILLJA'S SUBDIVISION OF PART OF BLOCK 48 OF CANAL TRUSTEE'S SUBDIVISION, ANTE-FIRE OF SECTION 7, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS;

TOGETHER WITH THE EAST-WEST 10 FOOT WIDE PUBLIC ALLEY AND THE NORTH-SOUTH 20 FOOT WIDE (AS DEDICATED BY ORDINANCE RECORDED JANUARY 3, 1980 (79-579) AS DOCUMENT NUMBER 25304602) PUBLIC ALLEY LYING EAST OF AND ADJOINING THE EAST LINE OF SAID LOT 4 IN SAID LILLJA'S SUBDIVISION AND SAID SOUTHERLY EXTENSION THEREOF; LYING NORTH OF AND ADJOINING THE NORTH LINE OF LOTS 10, 11 AND 12; LYING SOUTH OF AND ADJOINING THE SOUTH LINE OF LOTS 7, 8 AND THAT PART OF LOT 9; LYING WEST OF AND ADJOINING THE EAST 2 FEET OF LOT 9 AND LYING SOUTH OF AND ADJOINING THE SOUTH RIGHT OF WAY LINE OF W. WALNUT STREET; ALL INCLUSIVE IN BARBOUR'S SUBDIVISION OF PART OF BLOCK 48 IN CANAL TRUSTEE'S SUBDIVISION, RECORDED JUNE 27, 1854, ANTE-FIRE, OF SECTION 7, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS;

TOGETHER WITH THE EAST-WEST 16 FOOT WIDE PUBLIC ALLEY LYING NORTH OF AND ADJOINING THE NORTH LINE OF LOTS 6, 7, 8, 9 AND THAT PART OF LOT 10; LYING SOUTH OF AND ADJOINING THE SOUTH LINE OF LOTS 5, 4, 3, 2 AND THAT PART OF LOT 1; LYING WEST OF AND ADJOINING THE WEST RIGHT OF WAY OF N. ASHLAND AVENUE AS WIDENED BY ORDINANCE AND ORDER OF POSSESSION FEBRUARY 9, 1945, COURT GENERAL NUMBER B-71144 AND LYING EAST OF AND ADJOINING THE EAST TERMINUS OF SAID EAST-WEST 10 FOOT WIDE PUBLIC ALLEY, ALL INCLUSIVE IN THE SUBDIVISION OF THAT PART OF THE EAST 132 FEET OF BLOCK 48 IN CANAL TRUSTEE'S SUBDIVISION RECORDED JUNE 22, 1886 AS DOCUMENT NUMBER 728560 OF SECTION 7, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS; ABOVE DESCRIBED PARCEL CONTAINING 5,465 SQUARE FEET OR 0.1255 ACRES, MORE OR LESS as shaded and legally described by the words "HEREBY VACATED" on the plat hereto attached as **Exhibit A**, which plat for greater clarity, is hereby made a part of this ordinance, be and the same is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacations.

SECTION 2. The City of Chicago hereby reserves for the benefit of Commonwealth Edison, AT&T/SBC, Comcast, their successors or assigns, a non-exclusive utility easement to operate, maintain, construct, replace and renew overhead wires, poles, and associated equipment and underground conduit, cables, and associated equipment for the transmission and distribution of electrical energy, telephonic and associated services under, over and along the alleys herein vacated, with the right of ingress and egress at all times. The grade of the vacated public way shall not be altered in a manner so as to interfere with the operation and maintenance of Commonwealth Edison, AT&T/SBC and/or Comcast facilities. No construction, buildings, permanent structures or obstructions shall occur or be placed over the area herein vacated without an express written release of easement by each of the involved utilities. Any relocation of facilities lying within the areas being vacated that is necessitated by the Developer, its successors or assigns, will be accomplished by the involved utility, and be done at the expense of the Developer, its successors or assigns.

SECTION 3. The alley vacations herein provided for are made upon the express condition that within 180 days after the passage of this ordinance and its related documents, and prior to recording, the Developer shall 1) deposit in the City Treasury of the City of Chicago, a quoted sum sufficient to defray the cost of work to public paving, curb, and related appurtenances associated with its project in the event that it defaults in its obligation to construct the directed improvements in accordance with the most current version of the Chicago Department of Transportation's Regulations for Opening, Repair and Construction in the Public Way and its appendices; and 2) submit for field inspection and approval of its construction of said improvements, to the CDOT Division of Infrastructure Management, Construction Compliance Unit, Room 905 City Hall, for return of the monies deposited there (minus any service fee).

SECTION 4. The vacations herein provided for are made upon the express condition that within 180 days after the passage of this ordinance, the Developer shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will accrue to the owner of the property abutting said part of public alleys hereby vacated the sum _____ dollars (\$ _____), which sum in the judgment of this body will be equal to such benefits.

SECTION 5. The vacations herein provided for are made under the express condition that the Developer, its successors and assigns, shall hold harmless, indemnify and defend the City of Chicago from all claims related to said vacations.

SECTION 6. The vacations herein provided for are also made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Developer shall file or cause to be filed for recordation with the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the associated full sized plat as approved by the Superintendent of Maps and Plats.

SECTION 7. This ordinance shall take effect and be in force from and after its passage and publication. The vacation shall take effect and be in force from and after recording of the approved ordinance and plat.
