ORDINANCE SHEN SHEN HEALTH & HARMONY AccL No. 283714 - 1 Permit No. 1096784

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SHEN SHEN HEALTH & HARMONY, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Awning(s) projecting over the public right-of-way adjacent to its premises known as 2764 N. Lincoln Ave..

Said Awning(s) at N. Lincoln Avenue measure(s): One (1) at thirteen (13) feet in length, and two (2) feet in width for a total of twenty-six (26) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of **B**usiness Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1096784 herein granted the sum of fifty (\$50.00) per annum in advance.

A 25% penalty will be added for payments received after due date.


