ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-2, Community Shopping District symbols as shown on Map No. 9-H

in the area bounded by:

A line 99 feet south of and parallel to West Roscoe Street; North Ashland Avenue; a line 124 feet South of and parallel to West Roscoe Street; and the public alley next west of and parallel to North Ashland Avenue.

To those of a B2-3, Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and due publication.
