BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No.9- N in the area bounded by

The alley next north of and parallel to West Belmont Avenue; a line 57 feet east of and parallel to North Natoma Avenue; West Belmont Avenue; and North Natoma Avenue,

to those of a C1-1 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

 - Distances are marked in feet and decimal places thereof, no dimension shall be assumed by scale measurement herein. Distances and/or bearings shown with a "D" in parenthesis (D) are record or deed values and field measured.
 - Compare this plot, legal description and all survey monuments before building, and immediately report any discrepancies to the surveyor.
 - The location of the property lines shown on the face of this plot are based on the legal description contained in the title commitment and shown herein.
