**REPORT OF THE COMMITTEE ON ZONING**

Reporting for your Committee on Zoning, Landmarks, and Building Standards which a meeting was held on September 1, 2011, I beg leave to recommend that YOUR HONORABLE BODY PASS various Ordinances transmitted herewith for the purpose of reclassifying the particular areas.

ORDERED, That the Commissioner of Buildings is hereby directed to issue a sign permit to Integrity Sign Company, 18621 S. 81<sup>st</sup> Ave Tinley Park, IL 60487, for the erection of a sign/signboard over 24 feet in height and/or over 100 square feet (in area of one face) at:

Party City-6560 W. Fullerton Chicago, IL 60707

Dimensions: length, 46 feet 1 inch; height, 4 feet 5 inches  
Height above grade/roof to top of sign: 15 feet 5in  
Total Square Foot Area: 204 square feet

Such sign shall comply with all applicable provisions of Chapter 17 of the Chicago Zoning Ordinance and all other applicable provisions of the Municipal Code for the city of Chicago governing the construction and maintenance of signs, billboards, signboards and related structures.
