*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to AUDITORIUM PARK ONE, LLC upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, four (4) Building Projection(s) projecting over the public right-of-way adjacent to its premises known as 63 - 69 E IDA B WELLS DR.

Said Building Projection(s) at E. IDA B WELLS Dr. measure(s):

One (1) at seventy-one (71) feet in length and twenty (20) feet in width for a total of one thousand four hundred twenty (1,420) square feet.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1604986 herein granted the sum of seven thousand six hundred thirty-four (\$7,634.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
