BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the C1-2, Neighborhood Commercial District symbols as shown on Map No. 9 - G in the area bounded by:

A line 198.50 feet North of and parallel to West Waveland Avenue; a public alley next East of and parallel to North Ashland Avenue; a line 148.50 feet North of and parallel to West Waveland Avenue; North Ashland Avenue.

To those of a B2-3, Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and approval.
