BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1, Neighborhood Shopping District and indications as shown on Map No. 14-J in the area bounded

The center line of West 62nd Street extending into vacated West 62nd Street; the 16 foot north-south public alley east of and parallel to South Pulaski Road; the south line of West 62nd Place extending into the vacated portion of West 62nd Place; South Pulaski Road

to those of a B3-1, Community Shopping District.

Section 2. This ordinance takes effect after its passage and approval.
