3/18/2015 Reilly (42) Ordinance Grant(s) of privilege in public way for Superior Park LLC Committee on Transportation and Public Way Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SUPERIOR PARK LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use eight (8) Caisson(s) under the public right-of-way adjacent to its premises known as 165 W. Superior St.

Said Caisson(s) at W. SUPERIOR STREET measure(s):

One (1) at five point three three (5.33) feet in length, and one point one seven (1.17) foot in width for a total of six point two four (6.24) square feet. Said caisson shall be approximately seventy-nine (79) feet below grade level.

One (1) at nine point three three (9.33) feet in length, and three point two five (3.25) feet in width for a total of thirty point three two (30.32) square feet. Said caisson shall be approximately seventy-eight (78) feet below grade level.

One (1) at eight point eight three (8.83) feet in length, and three (3) feet in width for a total of twenty-six point four nine (26.49) square feet. Said caisson shall be approximately seventy-eight (78) feet below grade level.

One (1) at eight (8) feet in length, and two point four two (2.42) feet in width for a total of nineteen point three six (19.36) square feet. Said caisson shall be approximately seventy-eight (78) feet below grade level.

One (1) at nine point three three (9.33) feet in length, and two point eight three (2.83) feet in width for a total of twenty-six point four (26.4) square feet. Said caisson is approximately ninety-seven (97) feet below grade level.

Said Caisson(s) at PUBLIC ALLEY measure(s):

One (1) at eight point eight three (8.83) feet in length, and three (3) feet in width for a total of twenty-six point four nine (26.49) square feet. Said caissons shall be approximately seventy-eight (78) feet below grade level.

One (1) at nine point three three (9.33) feet in length, and three point two five (3.25) feet in width for a total of thirty point three two (30.32) square feet. Said caisson shall be approximately seventy-eight (78) feet below grade level.

One (1) at four point three three (4.33) feet in length, and point eight three (.83) feet in width for a total of three point five nine (3.59) square feet. Said caisson is approximately eighty (80) feet below grade level.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1116788 herein granted the sum of four hundred (\$400.00) per annum in advance.
