ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B3-2 Community Shopping District symbols and indications as shown on Map No.11-H in the area bounded by

a line 42 feet south of and parallel to West Wilson Avenue; the alley next east of and parallel to North Ravenswood Avenue; a line 92 feet south of and parallel to West Wilson Avenue; and North Ravenswood Avenue,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

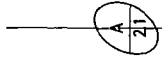


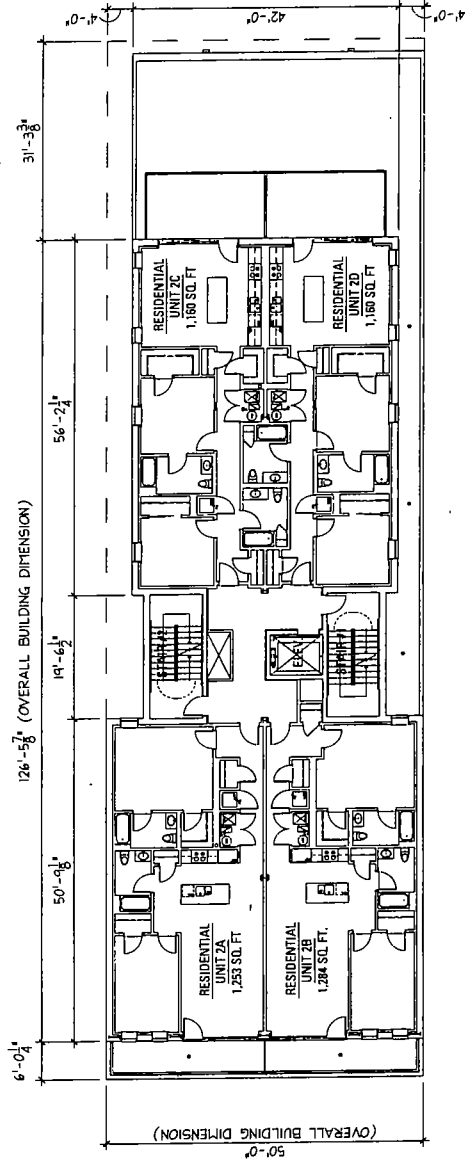
FIRST FLOOR PLAN

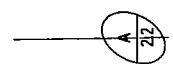

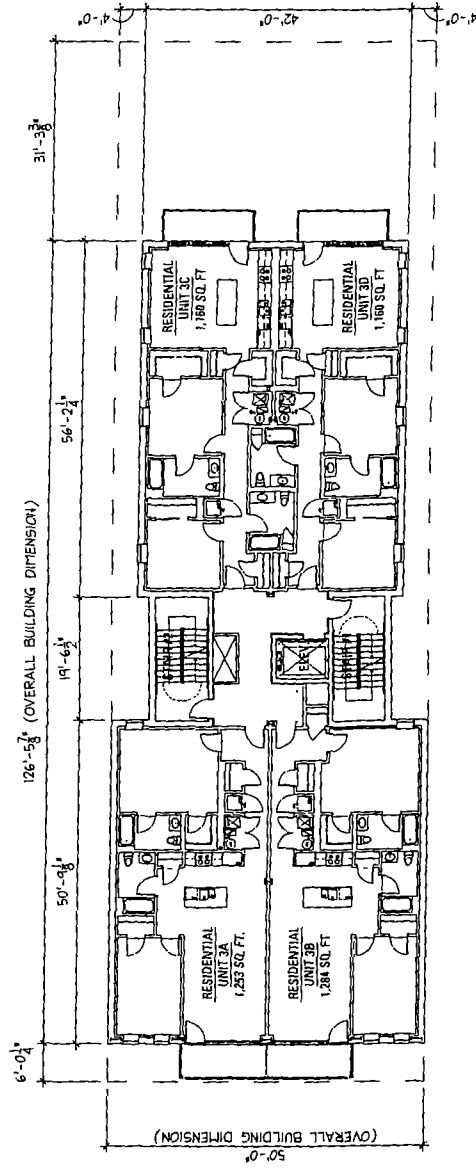


SECOND FLOOR PLAN

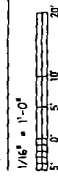

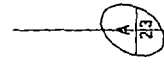


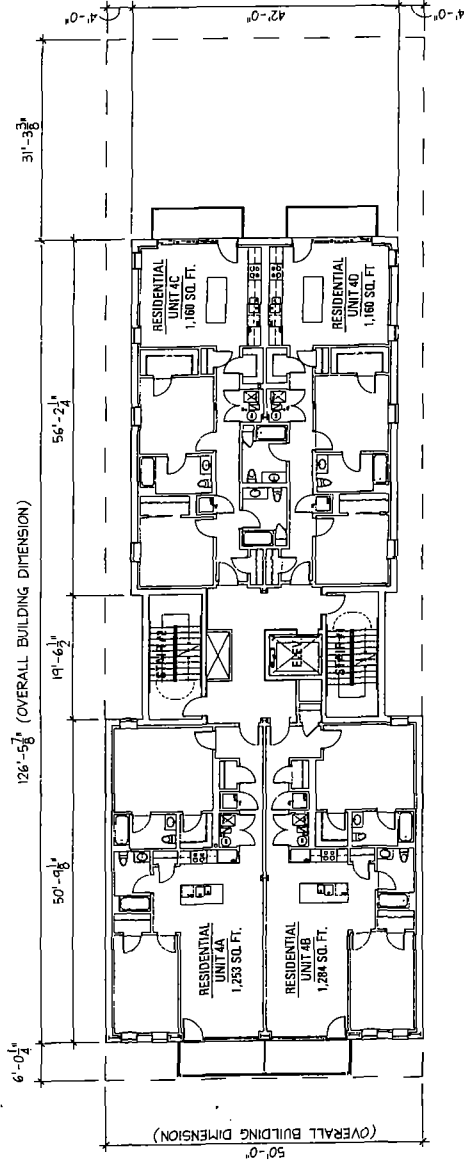
THIRD FLOOR PLAN

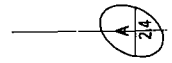
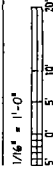

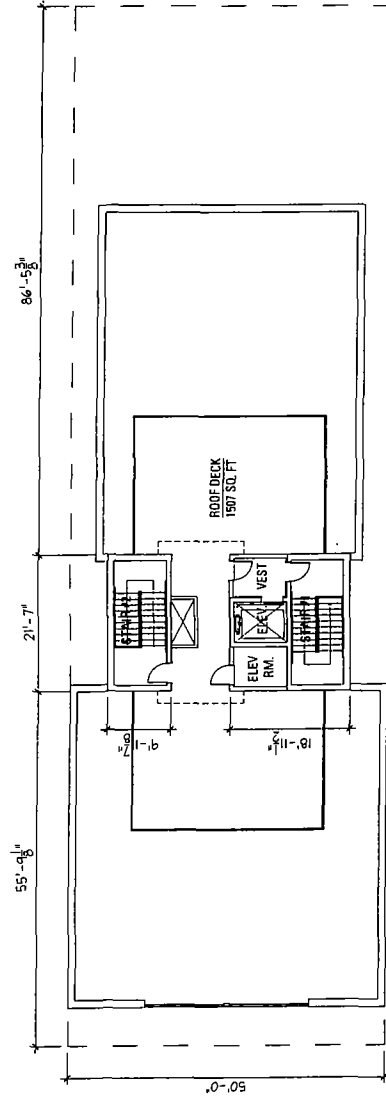
FOURTH FLOOR PLAN

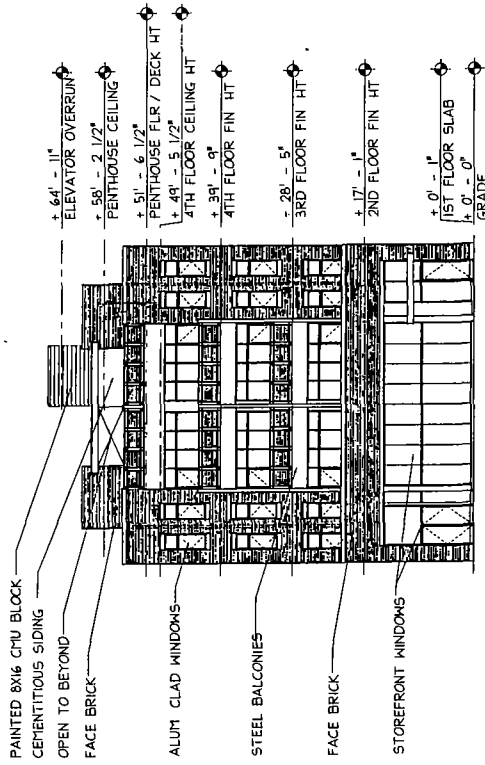




EAST ELEVATION
