IRONSIDE BAR & GALLEY

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to IRONSIDE BAR & GALLEY, upon the terms and subject to the conditions of this ordinance to maintain and use one (1) sign(s) projecting over the public right-of-way attached to its premises known as 546 N. Wells St..

Said sign structure(s) measures as follows; along N Wells St:

One (1) at five (5) feet in length, one point three four (1.34) feet in height and twelve (12) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1124398 herein granted the sum of one hundred (\$100.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.

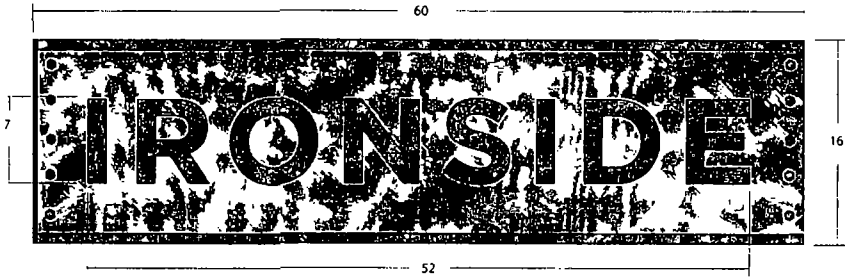

Blade Sign \$4800  
Installation \$800



Projecting blade sign to look like iron I beam with reverse channel halo lit letters

Welded Aluminum construction  
Back plate to be 1/4" aluminum plate with welded angle arm supports  
Sign body to be .050 aluminum mounted to angle arm supports with stainless nut and bolt

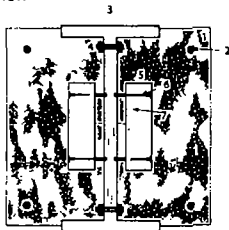
IRONSIDE letters to be welded construction  
.063 faces and .050 returns (2 deep)  
backing to be clear polycarbonate mounted to sign body with .75" spaceoff  
wired with white mini LED modules  
sign will be wired to a timer and dimmer switch

Sign will be bolted to existing brick building with concrete bolt and anchor

cost for permitting is not included

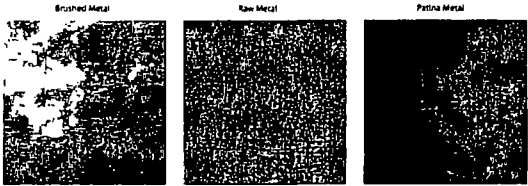


Side View
