**West 19<sup>th</sup> Street; a line 100 feet West of and parallel to South Morgan Street; the public alley next South of and parallel to West 19<sup>th</sup> Street; a line 125 feet West of and parallel to South Morgan Street.**

**To those of an RM5, Residential Multi-Unit District**

**SECTION 2. This Ordinance takes effect after its passage and approval.**

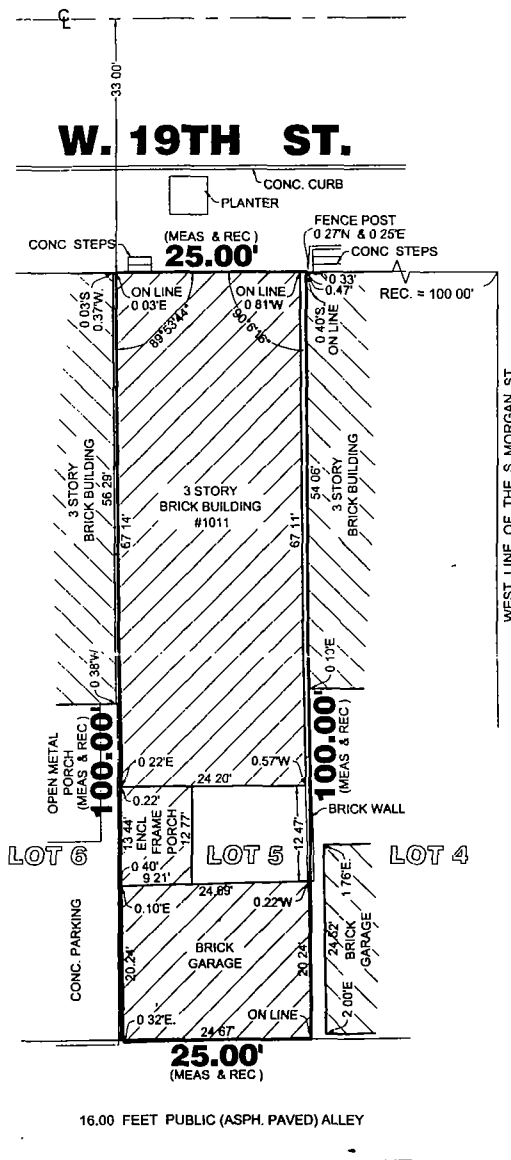
