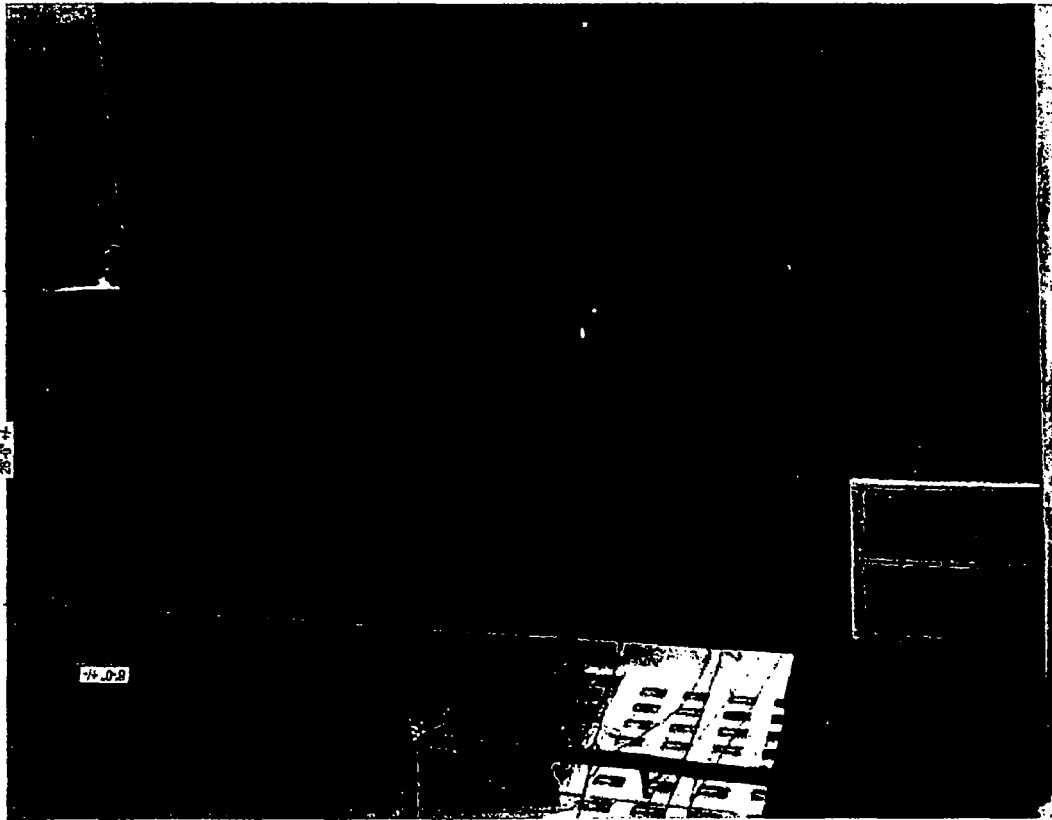


PHOTO SURVEY OF EXISTING

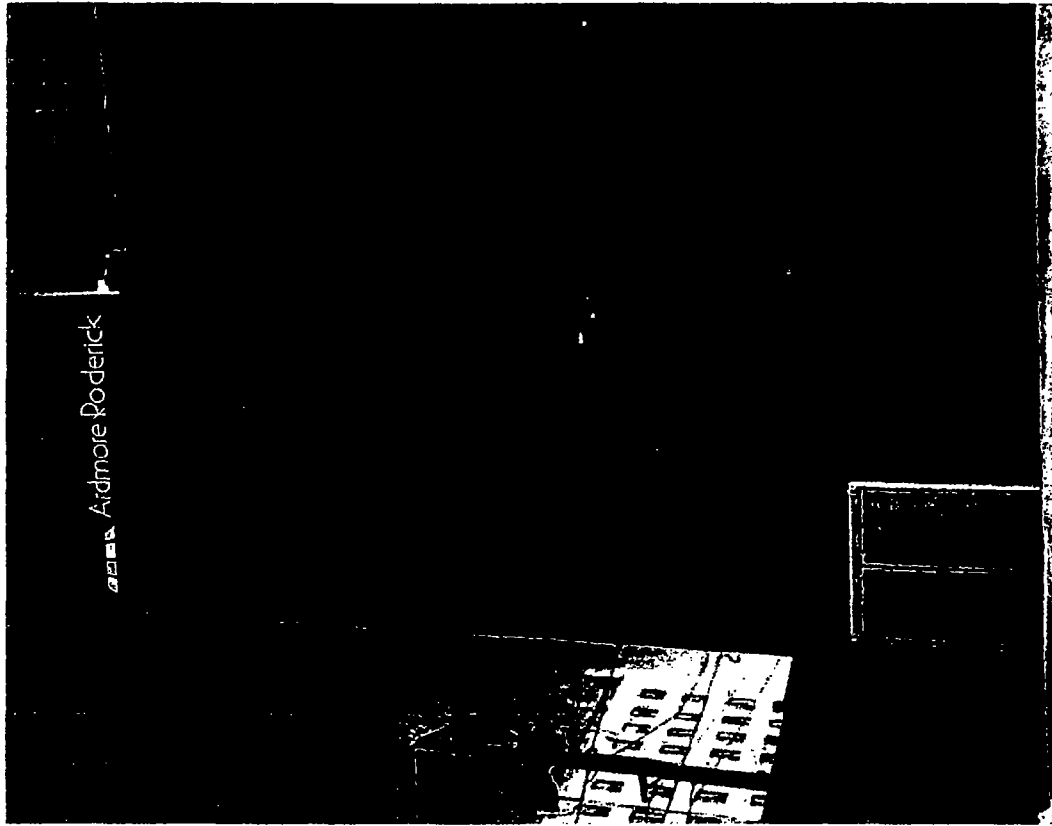


PHOTO SURVEY OF PROPOSED

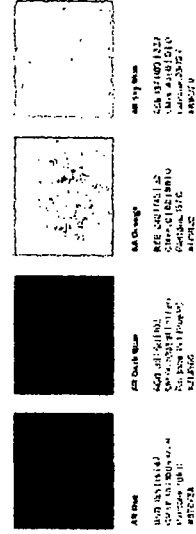
