ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago (“the Chicago Zoning Ordinance”) be amended by changing all the *M1-2 Limited Manufacturing/Business Park District* symbols and indications, as shown on Map No. 2-I, in the area bounded by

The alley next north of and parallel to West Adams Street; a line 78 feet east of and parallel to South Washtenaw Avenue; West Adams Street; and a line 52 feet east of and parallel to South Washtenaw Avenue,

to those of an *RT-4 Residential Two-Flat, Townhouse and Multi-Unit District*.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

Proposed Land Use: The subject property consists of a single lot of record, which such lot is presently vacant and unimproved. 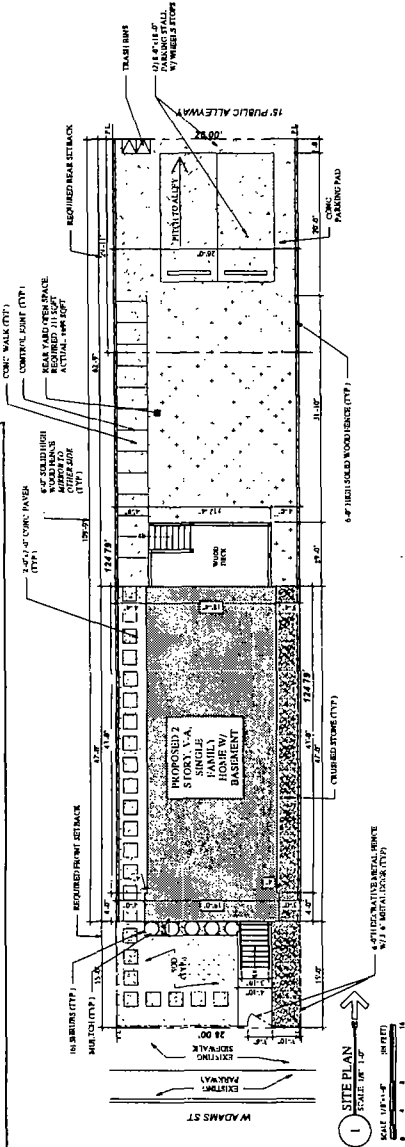
