## ORDINANCE AMENDMENT Acct. No. 11071 - 6 Permit No. 1085911

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

#### Section 1:

The ordinance passed by the City Council of the City of Chicago for FAMILY DOLLAR #1629 on 05/13/2009, and printed upon page 61587 of the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words "Permission and authority are hereby given and granted to FAMILY DOLLAR #1629, upon the terms and subject to the conditions of this ordinance to maintain and use two (2) sign(s) projecting over the public right-of-way attached to its premises known as 8341 S. Cottage Grove Ave..

Said sign structure(s) measures as follows; along S. Cottage Grove: One (1) at thirty-two (32) feet in length, four (4) feet in height and twelve (12) feet above grade level.

Said sign structure(s) measures as follows; along S. Cottage Grove: One (1) at ten (10) feet in length, eight (8) feet in height and thirteen point five (13.5) feet above grade level.

The grantee shall pay to the City of Chicago as compensation for the privilege #1085911 herein granted the sum of six hundred (\$600.00) per annum in advance."

and inserting in their place the words

"Permission and authority are hereby given and granted to FAMILY DOLLAR #1629, upon the terms and subject to the conditions of this ordinance to maintain and use one (1) sign(s) projecting over the public right-of-way attached to its premises known as 8341 S. Cottage Grove Ave..

Said sign structure(s) measures as follows; along S. Cottage Grove: One (1) at ten (10) feet in length, eight (8) feet in height and thirteen point five (13.5) feet above grade level.

The grantee shall pay to the City of Chicago as compensation for the privilege #1085911 herein granted the sum of three hundred (\$300.00) per annum in advance."
