BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RM-5 Residential Multi-Unit District symbols and indications as shown on Map No. 8-E in an area bound by:

A line 68.00 feet south of and parallel to East 33rd Boulevard; the alley next east and parallel to South Prairie Avenue; a line 212.00 feet south of and parallel to East 33rd Boulevard; and South Prairie Avenue.

To those of a RS-3 Residential Single-Unit (Detached House) District.

SECTION 2. This ordinance takes effect after its passage and due publication.
