***SECTION 1.*** Title 17 of the Municipal Code, the Chicago Zoning Ordinance,

symbols and indications as shown on Map No.9-1 in the area bounded by

North Elston Avenue; a line 23.47 feet northwest of and parallel to  
North Troy Street; the alley next north of and parallel to West  
Roscoe Street; and a line 72.30' northwest of and parallel to North  
Troy Street;

to those of a C1-2 Neighborhood Commercial District is hereby established in the  
area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and  
due publication.

12. Reason for rezoning the property The existing 2-story mixed-use building will remain. The reason for the

change is to lawfully convert from 1 dwelling unit to 3 dwelling units, and to allow a 3-story addition behind the building at 3504 N. Elston for a total of 3 dwelling units.

13. Describe the proposed use of the property after the rezoning. Indicate the number of dwelling units; number of parking spaces; approximate square footage of any commercial space; and height of the proposed building. (BE SPECIFIC)

The existing 2-story mixed use building will be renovated. There are 2 commercial spaces at grade each containing 1,269 square feet ("SF") and 2,674, SF, respectively. The building will be legally converted from 1 dwelling unit to 3 dwelling units.

Further, a 3-story addition will be built at the rear of 3504 N. Elston. This addition will have a height of 46'-6" and contain 1 dwelling unit. When complete, there will be 2 commercial spaces, 3 dwelling units and 2 new parking spaces located on-site.
