ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the *RT-4 Residential Two-Flat, Townhouse and Multi-Unit District* symbols and indications as shown on Map No. 5-G in the area bounded by

a line 247.22 feet north of and parallel to West Webster Avenue; North Halsted Street; a line 222.22 feet north of and parallel to West Webster Avenue; and the alley next west of parallel to North Halsted Street,

to those of a *RM-5 Residential Multi-Unit District*

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



11. Current Use of the Property: The subject property consists of a single lot of record. The site is currently improved with an old three-story (with basement) three-unit *residential* building and a detached garage (with roof deck). The existing building is *orange-rated* on the *Chicago Historical Resources Survey*, and – too, is *non-conforming* under the current Zoning Ordinance (*RT-4*).
12. Reason for rezoning the property: The Applicant is seeking a *Zoning Map Amendment* in order to permit the rehabilitation and renovation of the existing (*non-conforming*) improvements, the programming for which includes the erection of a one-story partial addition above the 3rd Floor. The proposed *Zoning Map Amendment* will also bring the existing *non-conforming* conditions into compliance under the current Zoning Ordinance.
13. Describe the proposed use of the property after the rezoning. Indicate the number of dwelling unit number of parking spaces; approximate square footage of any commercial space; and height of the proposed building. (BE SPECIFIC) The subject property consists of a single lot of record. The site is currently improved with an old three-story (with basement) three-unit *residential* building and a detached garage (with roof deck). The existing building is *orange-rated* on the *Chicago Historical Resources Survey*, and – too, is *non-conforming* under the current Zoning Ordinance (*RT-4*). The Applicant is seeking a *Zoning Map Amendment* in order to permit the rehabilitation and renovation of the existing improvements, and – also, to bring the existing *non-conforming* conditions into compliance under the current Zoning Ordinance. The programming for the proposed renovations includes the preservation and restoration of the existing front façade and side walls, as well as the erection of a one-story partial addition above the 3rd Floor, which will follow the lines of the existing building. There is, and will remain, a total of three (3) *dwelling units* within the principal building, which such units will undergo interior renovations as part of the rehabilitation plan. A component of the proposal also calls for the erection of a new three-car detached garage (with roof deck), which will replace and improve the existing accessory structure. The building, with proposed 4th Floor addition, will measure *47 feet-0 inches (*to the underside ceiling of the 4th Floor*) in height and such new improvements will be predominantly masonry in construction. *[*The Applicant will seek a Variation or other appropriate administrative relief for an increase in the maximum allowable height by 2 feet - not more than 10%.*]
