ORDINANCE 2501 N. Richmond LLC Acct. No. 386321 - 1 Permit No. 1109476

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 2501 N. Richmond LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Façade(s) projecting over the public right-of-way adjacent to its premises known as 2501 N. Richmond St..

Said Facade(s) at W. Altgeld measure(s):

One (1) at thirty-four point seven five (34.75) feet in length, and point five (.5) feet in width for a total of seventeen point three eight (17.38) square feet. Existing facade is approximately twenty-nine (29) feet in height.

One (1) at seventy-three point one (73.1) feet in length, and point three (.3) feet in width for a total of twenty-one point nine three (21.93) square feet. Existing façade is approximately twenty-nine (29) feet in height.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1109476 herein granted the sum of zero (\$.00) per annum in advance.

A 25% penalty will be added for payments received after due date.




