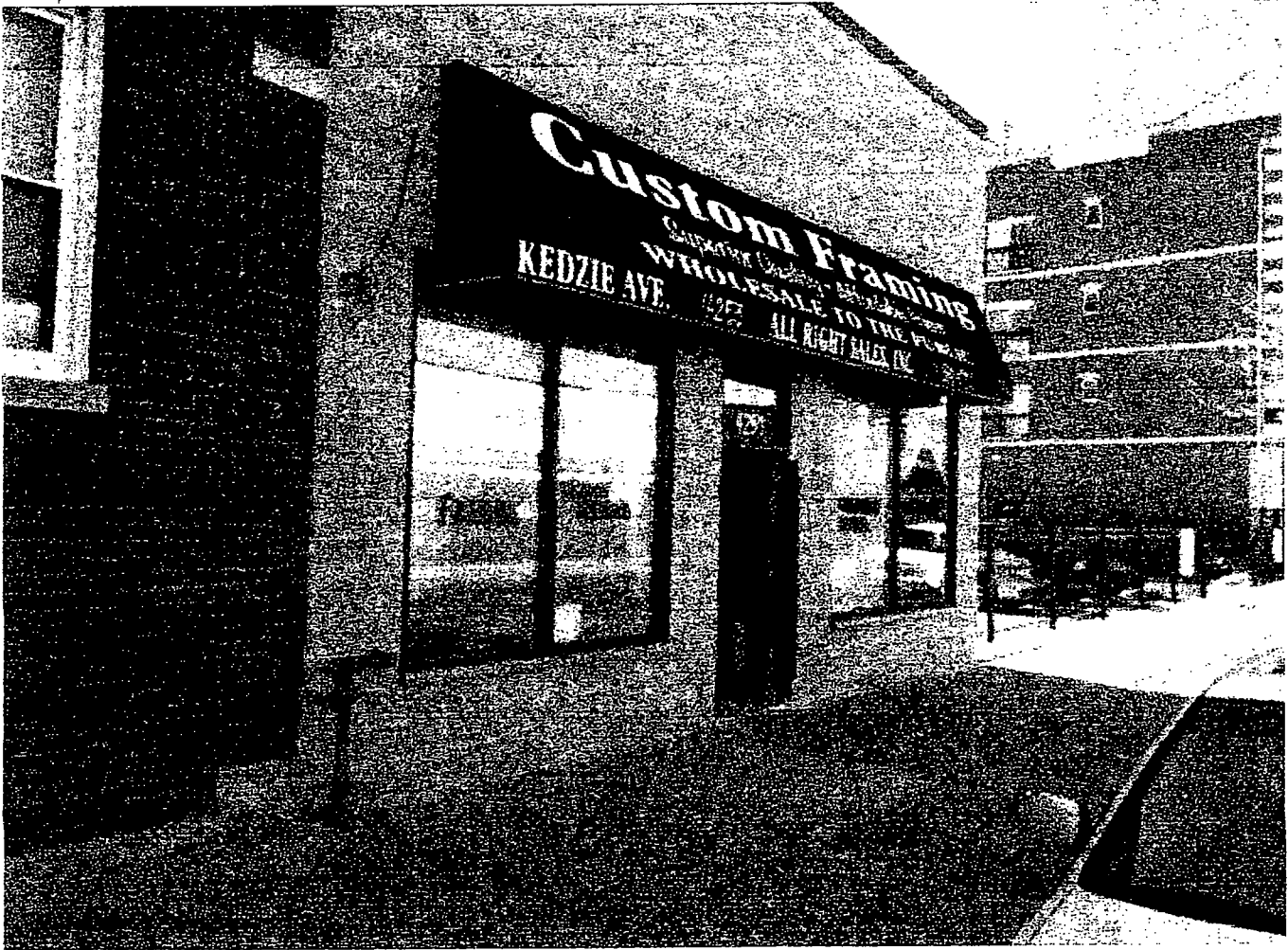

I also understand that the standing/loading zone may be removed at the Alderman's discretion or at the urging of any City Department.
