Pursuant to Section 10-20-430 of the Municipal Code of Chicago, the Commissioner of Transportation is hereby authorized and directed to exempt Sheridan Red Line, LLC, Chicago, Illinois 60613, from the provisions requiring barriers as a prerequisite to prohibit alley ingress and egress to parking facilities for 949 W. Dakin Street
