ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the **B1-2 Neighborhood Shopping District**, and B3-2 Community Shopping District as shown on Map 13-I in the area bounded by:

North Western Avenue, a line 489 feet South of West Bryn Mawr Avenue, the alley West of and parallel to North Western Avenue, and the alley South of and parallel to West Bryn Mawr Avenue,

to those of **C2-2 Motor Vehicle Related Commercial District**

SECTION 2. This ordinance takes effect after its passage and approval.
