Grant(s) of Privilege in Public Way for Lady of the Resurrection Committee on Transportation and Public Way ORDINANCE OUR LADY OF THE RESURRECTION Acct. No. 6772 - 1 Permit No. 1095756

Se It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to OUR LADY OF THE RESURRECTION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Pedestrian Sky Bridge extending over the public right-of-way adjacent to its premises known as 5645 W. Addison St.

Said pedestrian sky bridge shall be sixty-two (62) feet in length and eleven (11) feet in width spanning West Addison Street approximately two hundred and eighteen (218) feet west of Central Avenue at a height of twenty-three (23) feet seven (7) inches. The sky bridge will connect the Medical Center and the parking structure at the third floor of the existing Medical Center and at the top plate of the existing parking structure.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1095756 herein granted the sum of four hundred (\$400.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 03/28/2011.
