**A line 60.60 feet North of and parallel to West 50th Street; a public alley next East of and parallel to South Kildare Avenue; a line 30.60 feet North of and parallel to West 50th Street; South Kildare Avenue.**

**To those of an RT3.5, Residential Two-Flat, Townhouse and Multi-Unit District**
