BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago - the *Chicago Zoning Ordinance*, be amended by changing all the *B3-2 Community Shopping District* symbols and indications as shown on Map No. 7-G in the area bounded by

the alley next north of and parallel to West Diversey Parkway; a line 51 feet east of and parallel to North Southport Avenue; West Diversey Parkway; and a line 25 feet east of and parallel to North Southport Avenue,

to those of a *B2-2 Neighborhood Mixed-Use District*.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
