ORDINANCE

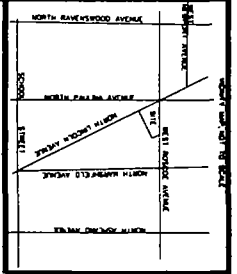
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2, Community Shopping District symbols as shown on Map No. 9-H for the property located in the area generally bounded by:

Roscoe Street; the alley next east of and parallel to North Lincoln Avenue; a line southeast of Roscoe Street and perpendicular to North Lincoln Avenue beginning at a point 81.77 feet along Lincoln Avenue; and North Lincoln Avenue,

to the designation of C1-2, Neighborhood Commercial District.

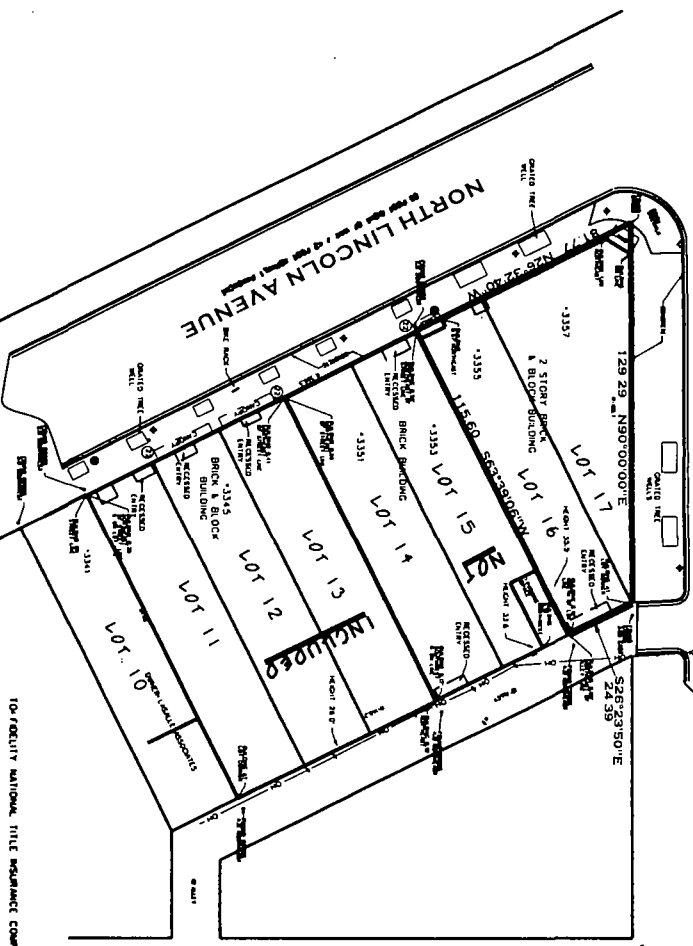
SECTION 2. This ordinance takes effect after its passage and publication.

As shown here on the map of 1878, Cook County, Illinois

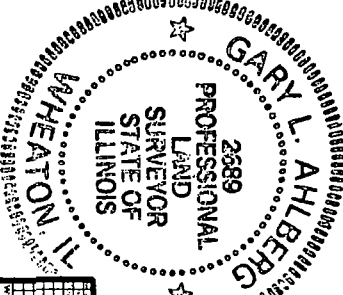

In compliance with the notice requirements of Section 17-13-0107 of the Chicago Zoning Ordinance, please be informed that on or about October 16, 2019, an application for an Amendment to the Chicago Zoning Ordinance will be filed on behalf of the Applicant, STRS L3 ACQ3, LLC, for the property located at 3357-61 North Lincoln Avenue.



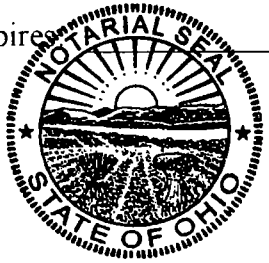

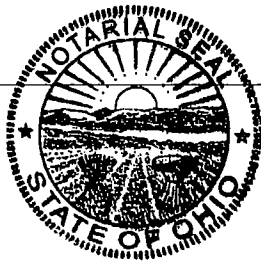
