REGARDS TO EDITH PRAIRIE SCHOOL
Acct. No. 403986 - 3
Permit No. 1129182

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to REGARDS TO EDITH PRAIRIE SCHOOL, upon the terms and subject to the conditions of this ordinance to maintain and use three (3) sign(s) projecting over the public right-of-way attached to its premises known as 326 N. Morgan St..

Said sign structure(s) measures as follows; along N MORGAN ST:

One (1) at eleven point eight four (11.84) feet in length, two point eight four (2.84) feet in height and fourteen point five nine (14.59) feet above grade level.

One (1) at fourteen point five (14.5) feet in length, one point six seven (1.67) feet in height and fourteen point five nine (14.59) feet above grade level.

One (1) at fifteen point one seven (15.17) feet in length, one point six seven (1.67) feet in height and fourteen point five nine (14.59) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1129182 herein granted the sum of seven hundred (\$700.00) per annum in advance.

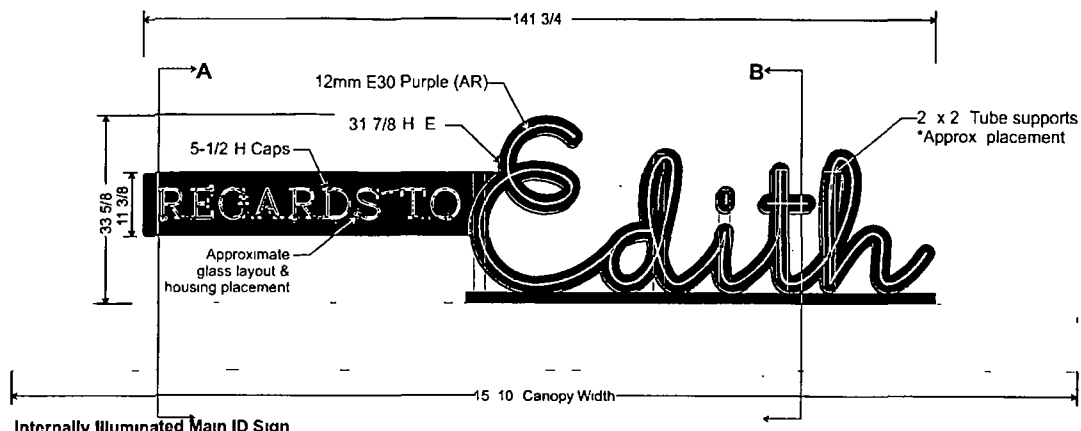
A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

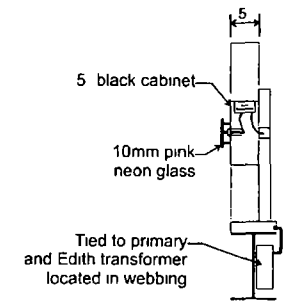

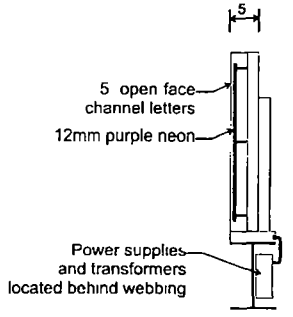

Regards To
 5 deep fabricated 125 aluminum cabinet painted black with exposed 10mm H37 Pink (AR) (clear tubes) with glass housings
 Regards to text graphics white vinyl graphics applied to cabinet face
 Internally illuminated with white LED lighting mounted to cabinet back wiring ran through 2 x 2 tube frame supports to E and down to raceway

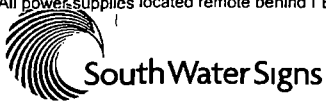
5 Deep fabricated open-face channel letters with 2 baffled back for wiring and mounting hardware
 Inside & out painted satin black mounted flush to common sign face with painted black low profile hardware
 Illuminated with 12mm E30 purple white glass on clear glass stand offs

All letters mounted to 2 H x 8 Deep extruded aluminum tube raceway with ripped top and 125 plate for access to wiring & hardware
 Additional 2 x 2 vertical aluminum tube supports welded to raceway for support as required during fabrication

Entire unit mounted through base of raceway into I Beam flange with nut and bolt hardware drilled in field

Power brought to sign location by others - run along canopy supports into rear of sign cabinet

All power supplies located remote behind I Beam attached to webbing and painted black to match
