A LINE 335.08 FEET IN LENGTH COMMENCING AT A POINT 1,635.84 FEET NORTHWEST OF WEST 54TH STREET AND ENDING AT A POINT 169.66 FEET SOUTH OF WEST 51ST STREET; SOUTH PULASKI ROAD, A LINE 1,560.84 FEET NORTH OF AND PARALLEL TO WEST 54TH STREET; AND A LINE 75 FEET IN LENGTH COMMENCING AT A POINT 1,560.84 FEET WEST OF SOUTH PULASKI ROAD AND ENDING AT A POINT 335.08 FEET SOUTHWEST OF SOUTH PULASKI ROAD.

To those of a C2-1 Motor Vehicle-Related Commercial District, and a corresponding use district is hereby established in the area above described.

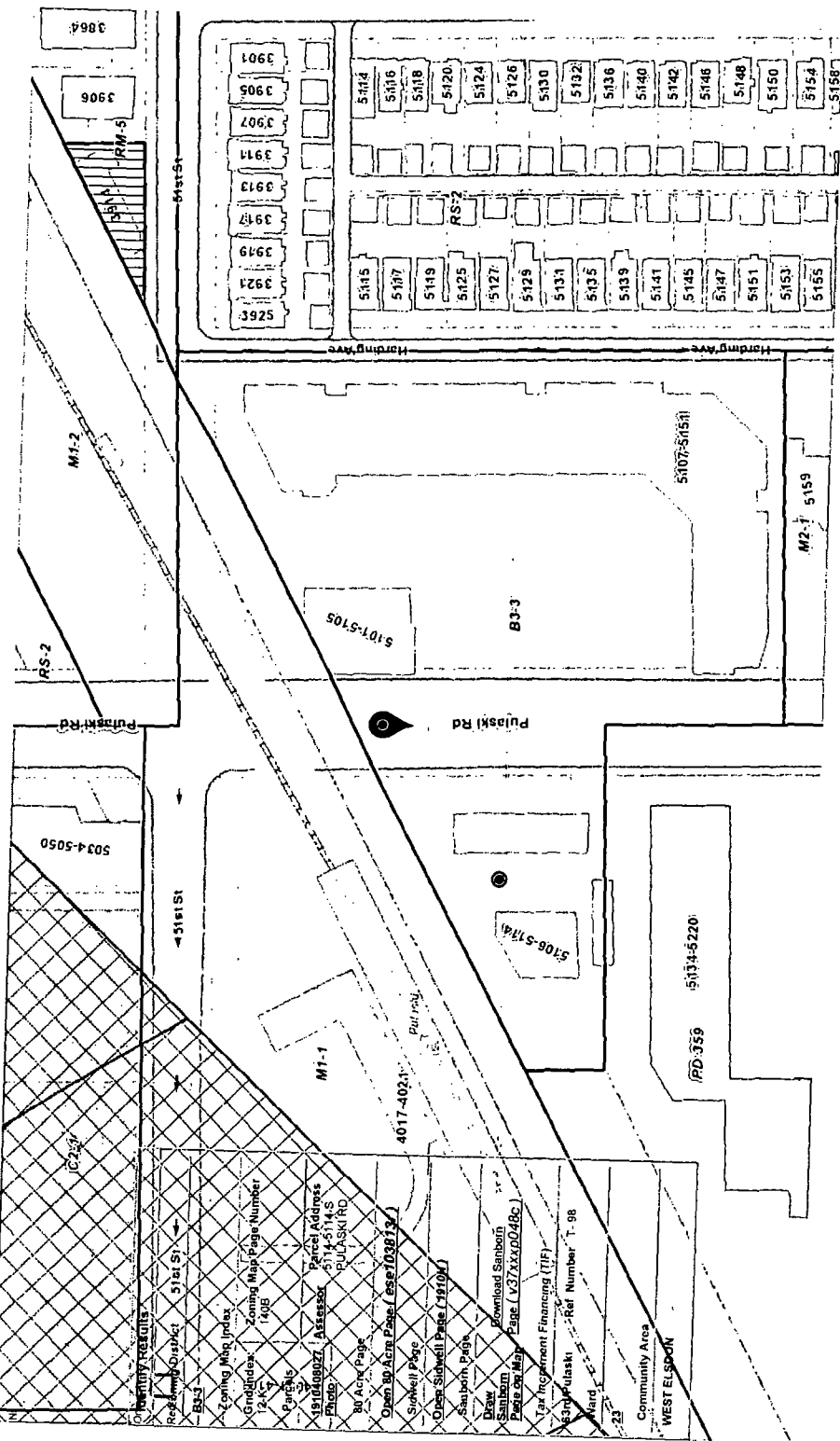
