***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the C2-2 Motor Vehicle-Related Commercial District symbols and indications as shown on Map No. 3-I in the area bound by

a line 123 feet south of and parallel to West LeMoyne Street; North Western Avenue; a line 173 feet south of and parallel to West LeMoyne Street; and the alley next west of and parallel to North Western Avenue

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.
