BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

Section 1. That an ordinance passed by the City Council on July 30, 1997 page #50167 of the Journal of Proceedings which reads, West Hubbard Street (north side) from a point 20 feet west of North Clark Street, to a point 60 feet west thereof- 15 minute standing zone — unattended vehicles must lights flashing- tow away zone after 15 minutes 6:00a.m. to 6:00p.m. (97-0612), in designated area, be and the same is hereby amended by striking there from, the following:

West Hubbard Street (north side) from a point 20 feet west of **N**orth Clark Street, to a point 60 feet west thereof and inserting in lieu thereof

East Ontario Street (north side) from a point 80 feet west of North St. Clair Street, to a point 40 feet west thereof -- tow-away zone except for 15 minute standing zone -- unattended vehicles must have lights flashing -- tow-away zone after 15 minutes -- 6:00 P.M. to 12:00 Midnight -- Monday through Friday and all day -- Saturday and Sunday (97-0605);

East Madison Street (south side) from a point 125 feet west of South Michigan Avenue, to a point 30 feet west thereof -- 15 minute standing zone -- unattended vehicles must have lights flashing -- tow-away zone after 15 minutes (97-0598);

West Hubbard Street (north side) from a point 20 feet west of North Clark Street, to a point 60 feet west thereof -- 15 minute standing zone -- unattended vehicles must have lights flashing -- tow-away zone after 15 minutes -- 6:00 A.M. to 6:00 P.M. (97-0612);

South Clinton Street (west side) from a point 30 feet north of West Polk Street, to a point 40 feet north thereof -- 15 minute standing zone -- unattended vehicles must have lights flashing -- tow-away zone after 15 minutes (97-0674);

East North Water Street (both sides) from North McClurg Court, to a point 600 feet east thereof -- no stopping, standing, parking -- towaway zone (97-0686);
