South Green Street; West 79th Street; South Peoria Street; and the public alley next north of and parallel to West 79th Street,

to those of a B1-3, Neighborhood Shopping District which is hereby established in the area described and a corresponding use district.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
