ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the B2-5 Neighborhood Mixed-Use District symbols and indications as shown on Map No. 11-I in the area bounded by:

West Lawrence Avenue; North Sacramento Avenue; the public alley next south of West Lawrence Avenue; a line 83.83 feet west of North Sacramento Avenue

to those of a B2-5 Neighborhood Mixed-Use District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

Narrative: The subject property consists of 10,479 square feet of land, and is currently a mixed-use, residential apartment building containing thirty residential dwelling units, first floor retail space, and no loading berth. The Applicant proposes to complete an interior remodeling of the building, adding four residential dwelling units for a total of 34 residential dwelling units, approximately 800 square feet of retail space, zero automobile parking spaces\*, 17 bicycle parking spaces and no loading berth. The height of the building will remain at 35 feet.

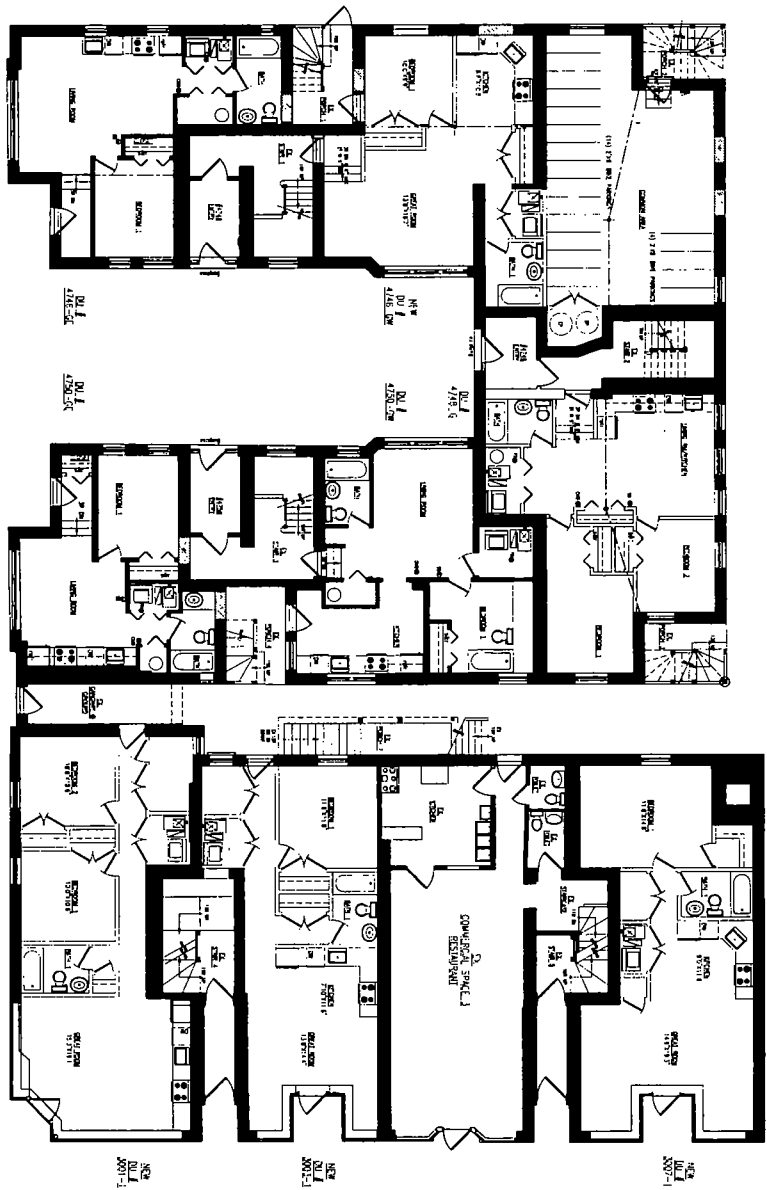
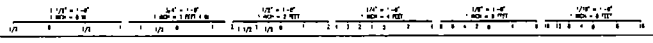

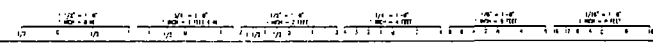


2-1 EXISTING FIRST FLOOR W/ (1) NEW DWELLING UNIT PROPOSED

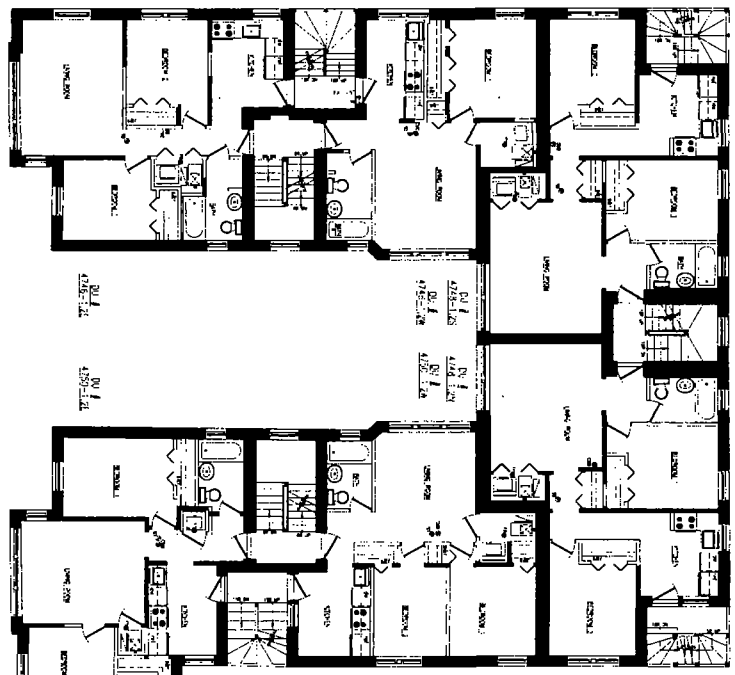
2-2 EXISTING FIRST FLOOR W/ (3) NEW DWELLING UNITS PROPOSED

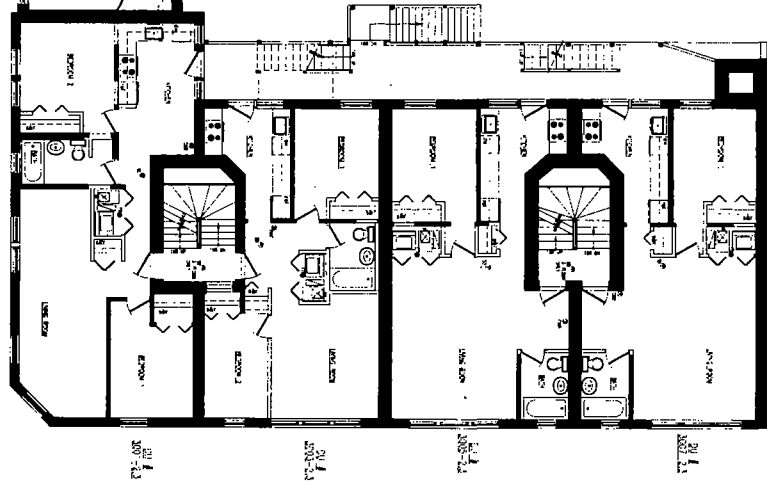

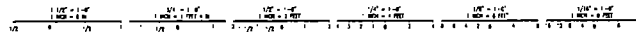


EXISTING SECOND AND THIRD FLOOR

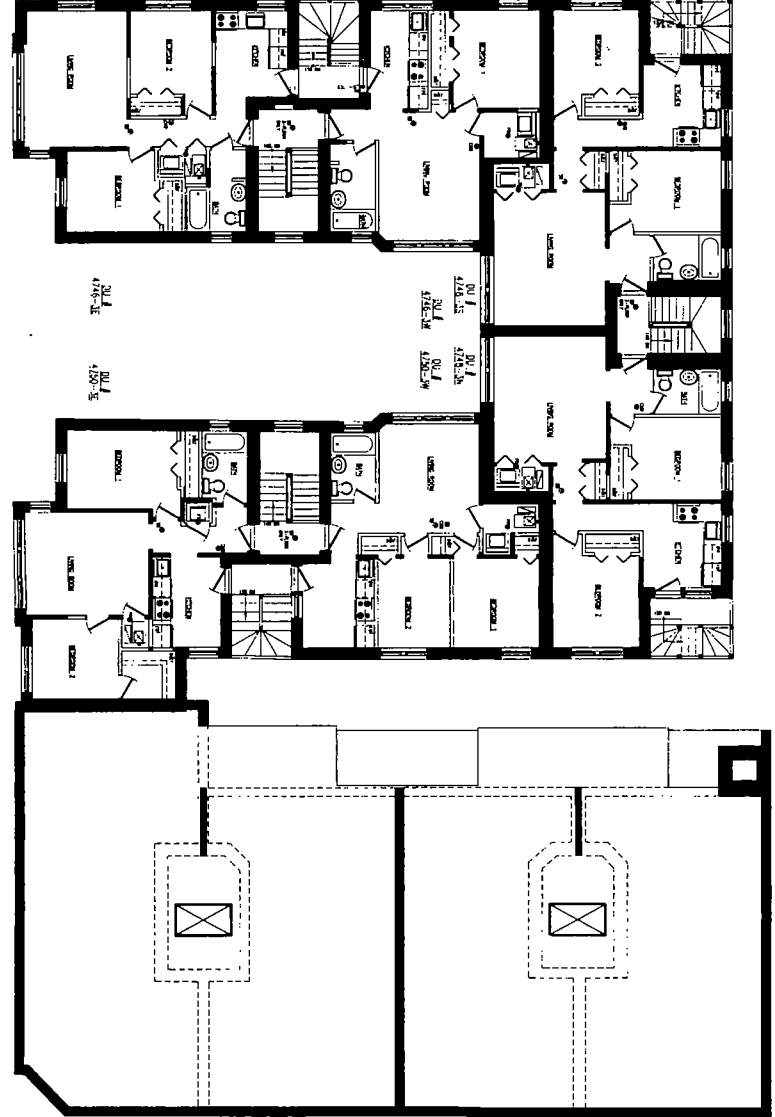
