TRAFFIC WARNING SIGN AND/OR SIGNALS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, that the Commissioner of Transportation is hereby authorized and directed to erect and/or amend Traffic Warning Signs and Signals, for the following locations are hereby designated:

WARD	TRAFFIC WARNING SIGNS AND/OR SIGNALS:
3	South State Street (east side) from East 26th Street to East 43rd Street; No Parking Street Cleaning, 7:00am to 9:00am Thursday, Tow Zone. [O2022-1244]
3	South State Street (east side) from East Roosevelt Road to East 26th Street; No Parking Street Cleaning, 7:00am to 9:00am, Monday Tow Zone. [O2022-1245]
3	South Michigan Avenue (west side) from East 35th Street to East 43rd Street; No Parking Street Cleaning Wednesday 7:00am to 9:00am Wednesday Tow Zone. [O2022-1246]
7	East 93rd Street and South Marquette Avenue; All Way Stop Sign, Stopping All Approaches. [O2022-954]
7	East 93rd Street and South Essex Avenue; All Way Stop Sign, Stopping All Approaches. [O2022-955]
14	West 54th Street; Stop sign on the intersection of South Sawyer Avenue. [Or2022-123]
23	5902-5912 South Menard Avenue (west side); Repeal No Parking Signs, 8:00am - 5:00pm, Monday through Friday [O2022-1005]
23	5119-5135 South Kilbourn Avenue (east and west side); Repeal One Hour Parking, 8:00am -6:00pm, Monday through Friday [O2022-1007]
23	Repeal Ordinance Which Reads: 5738 West 59th Street; Stop Sign [O2022-1088]
35	West Belmont Avenue between North Central Park Avenue and North Kedzie Avenue (south side); Real Rush Hour Restrictions [O2022-423]
35	North Pulaski Road between West Wilson Avenue and West Sunnyside Avenue (east side), Repeal Rush Hour Restrictions [O2022-424]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.


