## ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1:** Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the M2-2 Manufacturing District as shown on Map No. 9-I in the area bounded by:

A line 887.52 feet north of and parallel to West Addison Street; a line 40 feet west of and parallel to North Talman Avenue.; a line 787.52 feet north of and parallel to West Addison Street; North Talman Avenue; a line 269.26 feet north of and parallel to West Addison Street; the east boundary line of the North Branch of the Chicago River

to those of a C1-2 Neighborhood Commercial District and a corresponding use district is hereby established in the area above described.

**SECTION 2:** Title 17, of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the C1-2 Neighborhood Commercial District symbols and indications within the area hereinabove described to the designation of Waterway-Neighborhood-Commercial Planned Development Number \_\_\_\_\_, which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development Attached and made a part thereto and to no others.

**SECTION 3:** This ordinance shall take effect upon its passage and due publication.

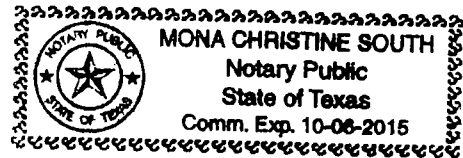

**PLAN OF DEVELOPMENT**

1. The area delineated herein as Planned Development Number TBD, (“Planned Development”) consists of approximately 213,313 square feet (4.89 acres) of property which is depicted on the attached Planned Development Boundary and Property Line Map (“Property”) and is owned or controlled by the Applicant, Chicago Near North Soccer, LLC.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant’s successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.
3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assign or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Housing and Economic Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

4. This Plan of Development consists of 14 Statements: a Bulk Regulations Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; a Right of Way Adjustment map (if applicable); Site Plan; Landscape Plan; Building Elevations (North, South, East and West) and Chicago Builds Green form prepared by Aria Group Architects. Full-sized copies of the Site Plan, Landscape Plan and Building Elevations are on file with the Department of Housing and Economic Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the

terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

5. The following uses are allowed in the area delineated herein as a Neighborhood Commercial Planned Development: sports and recreation, participant, indoor and outdoor sports fields, entertainment and spectator sports, training and fitness services, massage therapy, retail sales, indoor and outdoor special events, banquets, and eating and drinking establishments. Use of the facility by the City, the Alderman and Not-for-profit organizations sponsoring events shall also be an allowed use. The following uses shall be prohibited: retail liquor stores, taverns.
6. Off street parking and off street loading facilities shall be provided in compliance with the Planned Development, subject to review and approval of the Department of Transportation and Department of Housing and Economic Development.
7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
8. The information in the tables and maps attached hereto sets forth data concerning the generalized land-use plan of the area delineated herein as the Planned Development. The underlying District shall be that of C1-2 zoning district.
9. The maximum permitted Floor Area Ratio (“FAR”) for the site shall be in accordance with the attached Bulk Regulations Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of TBD square feet.
10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Housing and Economic Development.
11. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
12. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor’s Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.

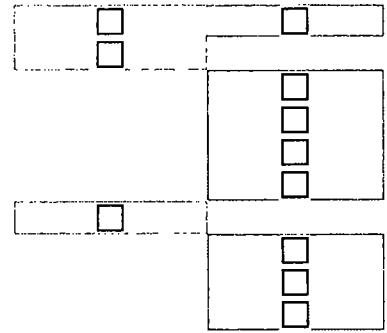

We will be utilizing daylighting where feasible for all public spaces. The building features large window systems on three sides as well as skylights on the upper floor. Artificial lighting will be energy efficient and designed to minimize load.

**Other sustainable strategies and/or Project Notes:**

The existing site will be graded level using only fill already onsite. Due to the large area of permeable pavers and turf, most rainwater will be managed on site to reduce erosion damage to the riverbank.

Non-sport site lighting and exterior building lights will all conform to the Dark Sky requirement.

Sustainable materials will be incorporated in to the building.

All paints and sealants will be low-VOC.

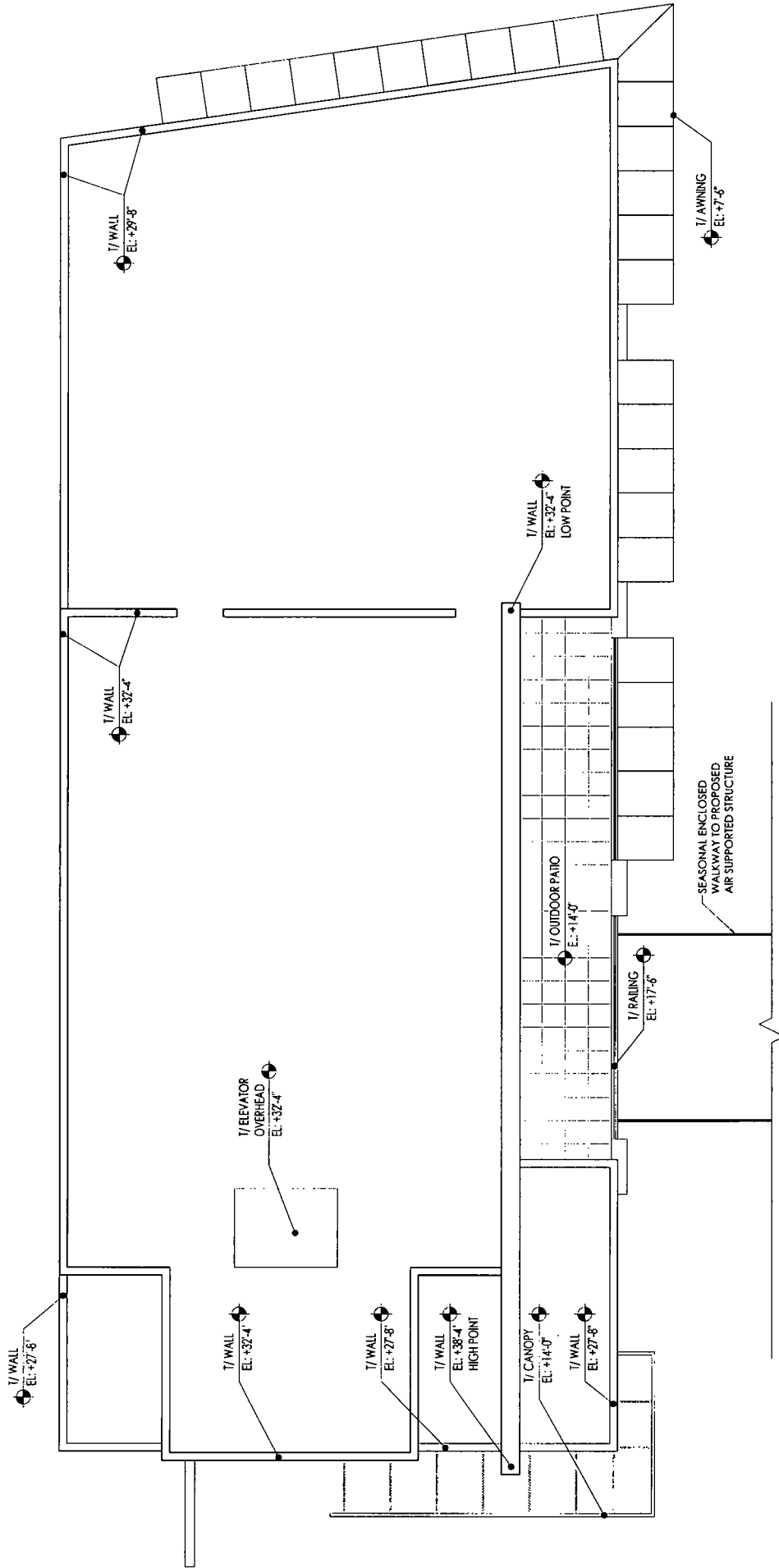




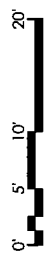
Conceptual Second Floor Plan

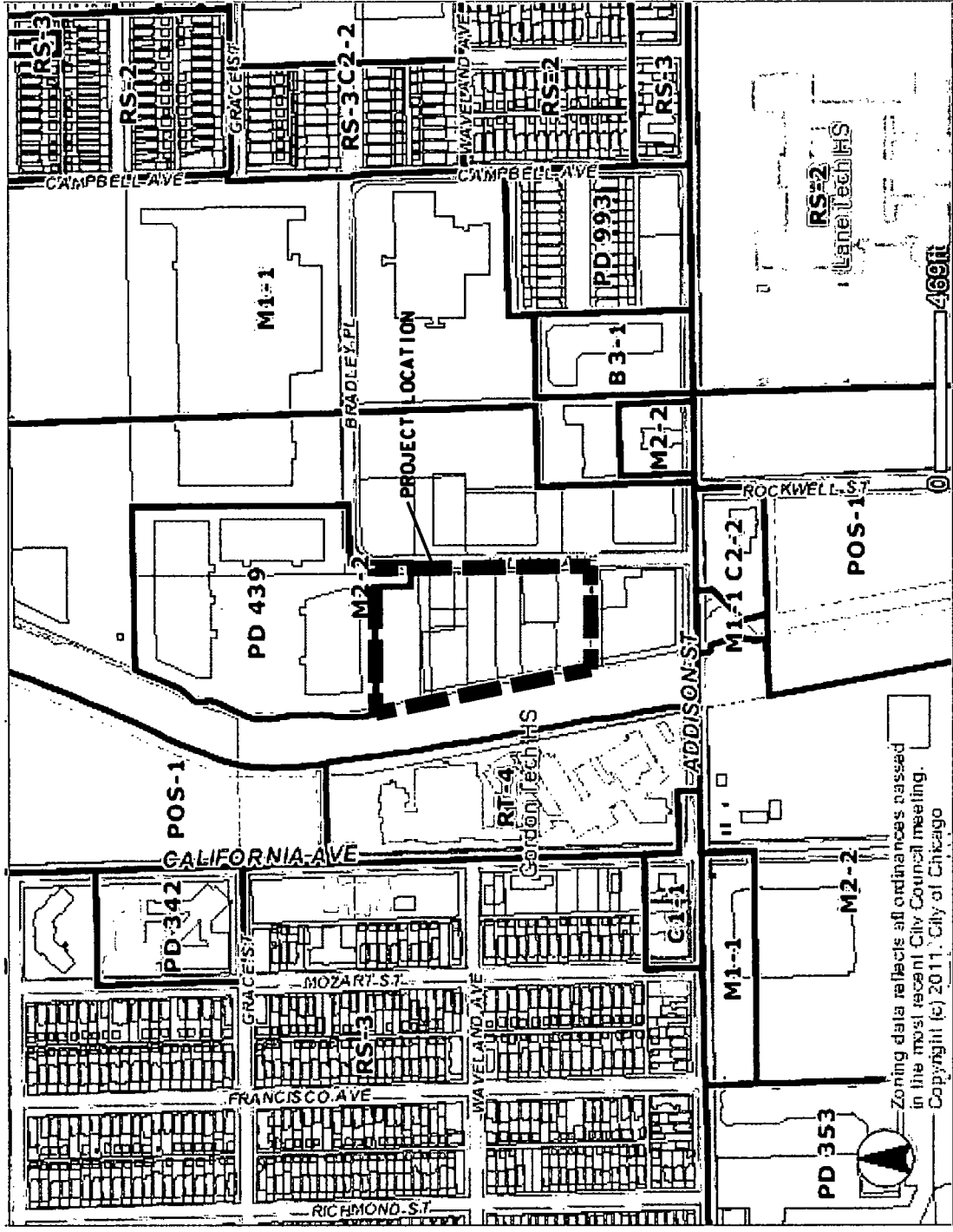


Conceptual Roof Plan

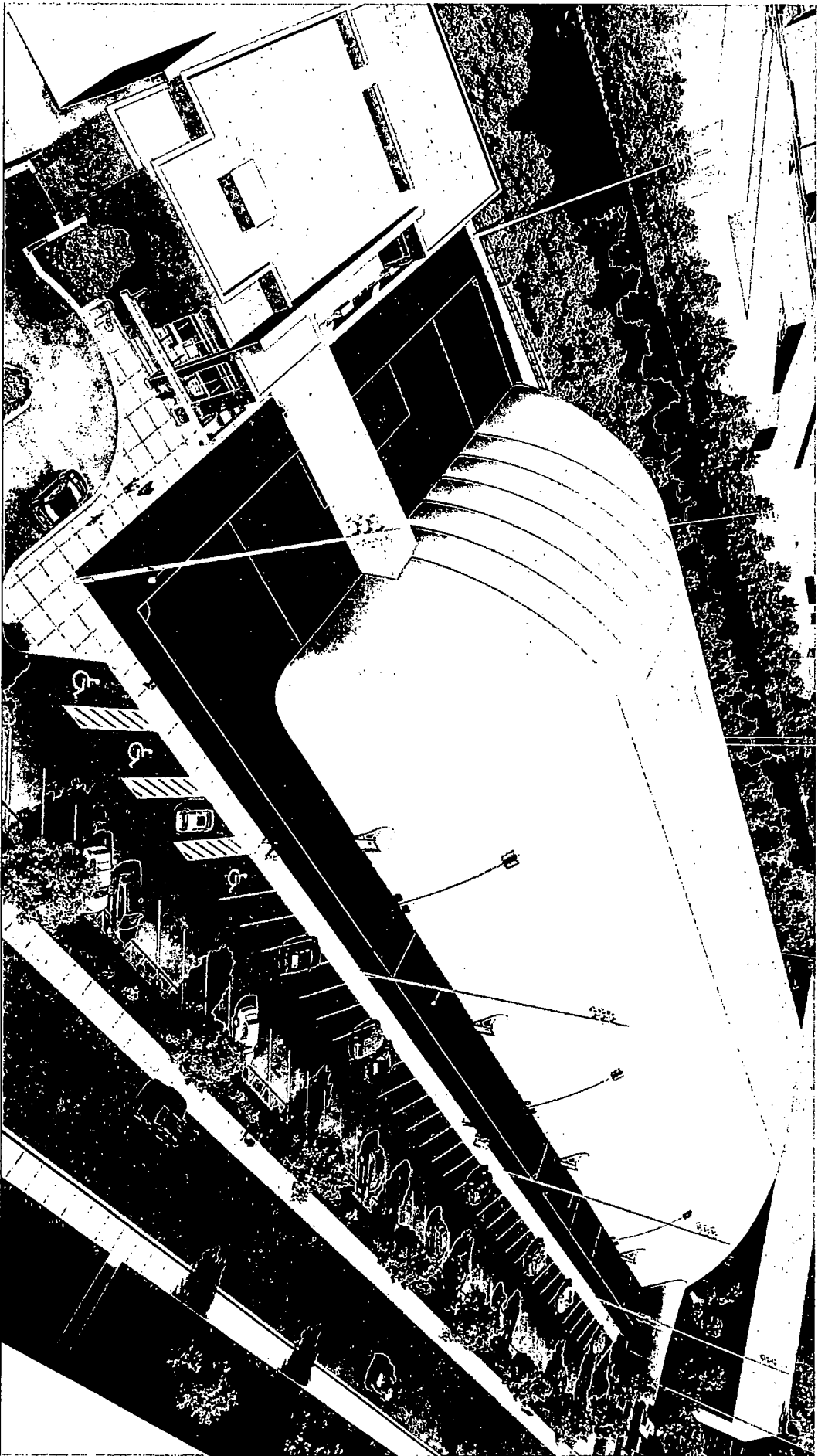


Rendered Aerial View - Without Dome
