ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all of the C1-3 Neighborhood Commercial District symbols and indications as shown on Map. No. 14-G in the area bounded by

Beginning at a line 20 feet southwest of and parallel to South Peoria Drive; A line from a point 20 feet southwest of South Peoria Drive and 41.65 feet southeast of and perpendicular to West 63rd Parkway to a point 398.76 feet north of West 63rd Street (said curve runs to the south/southwest an arc distance of 181.96 feet, with a radius of 211.17 feet and a chord length of 176.36 feet); a line 687.79 feet west of the centerline of South Halsted Street; West 63rd Street; and West 63rd Parkway running to the north/northeast to the point of beginning,

to the designation of Residential Business Planned Development Number ____, which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development attached and made a part thereto and to no others.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

NARRATIVE**

I. Applicant

Thrive Englewood, LLC

Thrive Englewood, LLC is a special purpose entity owned by DL3 Realty LP (“DL3 Realty”) and created specifically as part of DL3 Realty’s proposed mixed-use, phased development at 914 West 63rd Street.

DL3 Realty is a well-respected and experienced real estate development firm committed to the transition of emerging communities through high impact developments.

DL3 Realty’s success is in creating a connection with municipalities and institutions to increase much needed private investment in underserved urban communities such as Englewood. DL3 Realty developed Englewood Square, a 50,000 sq. ft. retail development which is located adjacent to the proposed development. With its proposed exciting mixed use, mixed-income development, DL3 Realty will further solidify its commitment in the Englewood community. DL3 Realty’s other developments include the 48,000 sq. ft. Jewel-Osco and the 42,000 sq. ft. Woodlawn Health Exchange, both located within the Woodlawn Community.

DL3 Realty’s proposed mixed-use, mixed income, pedestrian friendly housing development, referred to as “Thrive Englewood” will be a beacon along 63rd Street.

II. Existing Site Conditions

The Subject Property, consisting of 105,166 sq. ft. (2.2 acres) is located at the northeast corner of West 63rd Street and South Sangamon Street. The Subject Property is vacant and located within the C1-3 Neighborhood Commercial District.

A. TIF District/Community Area

The Subject Property is located within the Englewood Mall TIF and Englewood Community Area.

The Subject Property is not located within an Industrial Corridor or the Lakefront Protection District.

III. Proposed Residential-Business Planned Development

The Applicant is seeking a Residential-Business Planned Development (“PD”) in order to permit the construction of a two-phased development within the Subject Property. The project will consist of two residential/mixed-use buildings comprised of a. a six-story, 61-unit building containing 59 dwelling units and two live-work units in Phase I, and b. a five-story, 47 unit building containing 44 dwelling units and three live-work units in Phase II. Applicant’s proposed PD will consist of four (4) subareas, as described below:

A. Subarea A:

Subarea A (consisting of 20,344 sq. ft.), will be improved with a) a 6-story mixed-use, mixed income building consisting of i) a retail/commercial unit (2,439 sq. ft.) within the first floor; ii) two (2) live/work units within the first floor; c) fifty-nine (59) dwelling units within the 2nd-6th floors, and d) seven (7) on-site parking spaces. (“Phase I Proposed Development”). As the Proposed Development exceeds the number of dwelling units permitted in a C1-3 District, a mandatory Planned Development is required. The Applicant will also seek FAR, MLA and height allowances due to Subject Property’s C1-3 zoning district, Transit Served location and the on-site location of its affordable dwelling units.

- **Proposed 6-story Mixed Use Building**

- 1. Retail/Commercial Units**

One (1) retail/commercial unit, consisting of 2,439 sq. ft. will be located within the first floor of the proposed mixed-use building

- 2. Work/Live Units**

Two (2) work/live units, with an average unit size of 968 sq. ft., will be located within the first floor of the proposed mixed-use building.

- 3. Amenity/Lobby space**

The proposed mixed-use building’s first floor will also include a management office, community room and fitness room.

A lobby, consisting of 1,346 s.f., will serve as the entrance to and connect the Phase I and Phase II buildings.

4. Residential dwelling units

Fifty-nine (59) dwelling units will be located within the 2nd -6th floors of the proposed mixed-use building. The proposed unit types are as follows:

One (1) bedroom: 25 dwelling units (average unit size: 604 sq. ft.)

Two (2) bedroom: 29 dwelling units (average unit size: 846-931 sq. ft.)

Three (3) bedroom: 5 dwelling units (average unit size: 1,230 sq. ft.)

5. Exterior On-site Parking

Seven (7) exterior parking spaces are located within Subarea A, which will be located in Phase I Proposed Development.

6. Bicycle Spaces

Sixteen (16) exterior bicycle spaces are located within Subarea A, which will be in the Phase I Proposed Development.

B. Subarea B

Subarea B (consisting of 18,719 sq. ft.), will be improved with a) a 5-story, multi-family, residential building consisting of i) three (3) live/work units within the first floor and forty-four (44) dwelling units within 2nd-5th floors (“Phase II Proposed Development”). The Applicant will seek FAR and MLA allowances based upon the Subject Property’s C1-3 district, Transit Served location and the on-site location of its affordable dwelling units.

• **Proposed 5-story Residential Building**

1. Work/Live Units

Three (3) work/live units, with an average unit size of 1,015 sq. ft., will be located within the first floor of the proposed residential building

2. **Amenity/Lobby space**

The proposed residential building's first floor will include a community room, management office, fitness room, and bike room.

3. **Residential dwelling units**

Forty-four (44) dwelling units will be located within the 2nd -6th floors of the proposed mixed-use building. The proposed unit types are as follows:

One (1) bedroom: 20 dwelling units (average unit size: 603-629 sq. ft.)

Two (2) bedroom: 24 dwelling units (average unit size: 890-925 sq. ft.)

C. **Subarea C**

Subarea C (consisting of 38,559 sq. ft.), will be improved with a paved and landscaped parking area, containing 58 dedicated parking spaces located along the eastern side of the Subject Property, along S. Sangamon St. The parking spaces will serve Phase I and Phase II buildings. Ingress and egress to the parking area will be through the main entry located along West 63rd Parkway.

In accordance with 17-10-0504-C of the Chicago Zoning Ordinance, a) five (5) parking spaces are required to serve the five (5) work/live units (Three (3) L/W in Phase I Building and Two (2) L/W in Phase II Building) and b) eight-one (81) residential parking spaces. Although the Subject Property qualifies as a Transit Served Location, and Applicant's amount of required residential parking is reduced to 41, Applicant plans to provide 65 parking spaces, which include i) seven (7) spaces on Subarea A, which will serve the retail uses within Phase I Building, and 58 parking spaces within Subarea C, which will serve the residents of Applicant's Proposed Phase I and Phase II Developments.

Subarea C will also contain a loading berth (10 ft. x 25 ft.) which will be shared by both buildings. A single loading berth will be sufficient for this Planned Development due to the extremely small amount of retail and live-work space.

Subarea C will also consist of 16,671 sq. ft. of open space.

D. Subarea D

Subarea D (consisting of 27,544 sq. ft.), will consist of open space/park, which is provided for the use and enjoyment of residents of the Phase I and Phase II Proposed Developments. Additionally, the area currently contains an underground detention facility which will serve all Subareas of the proposed Planned Development. This detention facility will protect against flooding and potential erosion.

IV. ARO Units

The Applicant is currently in discussions with the Department of Housing regarding the affordable housing plan for Proposed Phase I and Phase II Buildings.

V. Transportation

The Subject Property is a Transit Served Location, as it is located within 1,320 feet of the CTA Green Line station at W. 63rd & South Halsted Ave. It is also served by CTA Bus Route 63 on 63rd St. and Bus Route 8 on Halsted.

VII. Community outreach

As part of promoting the benefits of its proposed development, representatives of the Applicant has met with Alderwoman Stephanie Coleman and discussed the Proposed Development. Applicant, with the assistance of Alderwoman Coleman's office, have held preliminary meetings with the community and plan to hold an additional community meeting to present the Proposed Development.

VIII. City Funds or Incentives

The Applicant is seeking TIF, LIHTC (9%) and HOME Funds. The Proposed Development is also being reviewed by the Department of Housing.

IX. Sustainable Development Policy

The Applicant are aware of and will comply with the City of Chicago's Sustainable Development Policy for Planned Development projects and have completed the required matrix pursuant to the policy. The Applicant have identified the options from the Sustainable Strategies Menu that it will utilize during its proposed phases of development. Please see the attached matrix.

X. MBE/WBE Hiring Strategy

The Applicant is aware of and will comply with the City's MBE/WBE policy for Planned Development projects. The Applicant plans to adopt employment goals of 26% MBE, 6% WBE and 50% City Residency as part of its proposed development.

XI. Internet/Cell Use

The Applicant is working on securing the necessary information regarding the anticipated level of building service for internet/sell use, and will submit to DPD to during the Planned Development application process.

STANDARD PLANNED DEVELOPMENT STATEMENTS

The Planned Development Statements describe the legal regulations and conditions that will control the development of the proposed project. The following statements shall be included in the ordinance; any proposed changes to these statements must be discussed and reviewed with the Chicago Department of Planning and Development. Based on the scope of the project, additional statements (listed at the end of this document) may be required. The following statements must be included in the ordinance:

1. The area delineated herein as Planned Development Number TBD, (Planned Development) consists of approximately 105,166 square feet of property which is depicted on the attached Planned Development Boundary and Property Line Map (Property) and is owned or controlled by the Applicant, Thrive Englewood, LLC.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined in Section 17-8-0400.
3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assigns or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Planned Development.

Ingress or egress shall be pursuant to the Planned Development and may be subject to the review and approval of the Departments of Planning and Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

Pursuant to a negotiated and executed Perimeter Restoration Agreement (“Agreement”) by and between the Department of Transportation’s Division of Infrastructure Management and the Applicant, the Applicant shall provide improvements and restoration of all public way adjacent to the property, which may include, but not be limited to, the following as shall be reviewed and determined by the Department of Transportation’s Division of Infrastructure Management:

- Full width of streets
- Full width of alleys

The Perimeter Restoration Agreement must be executed prior to any Department of Transportation and Planned Development Part II review permitting. The Agreement shall reflect that all work must comply with current Rules and Regulations and must be designed and constructed in accordance with the Department of Transportation's Construction Standards for work in the Public Way and in compliance with the Municipal Code of Chicago Chapter 10-20. Design of said improvements should follow the Department of Transportation's Rules and Regulations for Construction in the Public Way as well as The Street and Site Plan Design Guidelines. Any variation in scope or design of public way improvements and restoration must be approved by the Department of Transportation.

4. This Plan of Development consists of eighteen (18) Statements: a Bulk Regulations Table; an Existing Land Use Map; an Existing Zoning Map/Planned Development Boundary and Property Line Map; Existing Site Plan, Proposed Site Plan, Overall Subarea Plan; Subarea A Plan; Subarea B Plan; Subarea C Plan; Subarea D Plan; Landscape Site Plan – Phase I; Enlarged Landscape Plan – Phase I; and Landscape Site Plan – Phase II; Enlarged Landscape Plan – Phase II; Landscape Details; Floor Plans – Phase I Building; Floor Plans - Phase II Building; Roof Plan – Phase I Building; Roof Plan – Phase II Building; Building Elevations (North, South, East and West) – Phase I Building; Building Elevations (North, South, East and West) – Phase II Building; Pedestrian Routes/Connectivity Plan; Vehicular and Loading Access Plan and Open Space Plan prepared by Perkins & Will and dated (date of Plan Commission presentation), submitted herein. Full-sized copies of the Site Plan, Landscape Plan and Building Elevations are on file with the Department of Planning and Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Chicago Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Chicago Zoning Ordinance, this Planned Development shall control.
5. In each of the following Sub Areas, the following uses shall be permitted in this Planned Development (PD) (describe in detail which uses are permitted and which are excluded for each Sub-Area):

Sub-Area A: All residential uses (including accessory uses) allowed within the C1-3 District, Artist Live/Work, Business Live/Work, Community Center, Restaurant (General and Limited), Retail and Accessory Parking.

Sub-Area B: All residential uses (including accessory uses) allowed within the C1-3 District, Artist Live/Work, Business Live/Work, Community Center, Restaurant (General and Limited), Retail and Accessory Parking.

Subarea C: Accessory Parking

Subarea D: Open Space/Park & Detention area

6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Planning and Development. Off-Premise signs are prohibited within the boundary of the Planned Development.
7. For purposes of height measurement, the definitions in the Chicago Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
8. The maximum permitted floor area ratio (FAR) for the Property shall be in accordance with the attached Bulk Regulations and Data Table. For the purpose of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations and Data Table has been determined using a net site area of 105,166 square feet and an overall FAR of 1.3.
9. Upon review and determination, Part II Review, pursuant to Section 17-13-0610, a Part II Review Fee shall be assessed by the Department of Planning and Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines, including Section 17-13-0800. Final landscape plan review and approval will be by the Department of Planning and Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Fleet and Facility Management and Buildings, under Section 13-32-085, or any other provision of the Municipal Code of Chicago.
12. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to Section 17-13-0611-A, by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.

13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. The Applicant shall obtain the number of points necessary to meet the requirements of the Chicago Sustainable Development Policy, in effect at the time the Part II review process is initiated for each improvement that is subject to the aforementioned Policy and must provide documentation verifying compliance.
15. The Applicant acknowledges that it is the policy of the City to maximize opportunities for Minority and Women-owned Business Enterprises ("M/WBEs") and city residents to compete for contracts and jobs on construction projects approved through the planned development process. To assist the city in promoting and tracking such M/WBE and city resident participation, an applicant for planned development approval shall provide information at three points in the city approval process. First, the applicant must submit to DPD, as part of its application for planned development approval, an M/WBE Participation Proposal. The M/WBE Participation Proposal must identify the applicant's goals for participation of certified M/WBE firms in the design, engineering and construction of the project, and of city residents in the construction work. The city encourages goals of (i) 26% MBE and 6% WBE participation (measured against the total construction budget for the project or any phase thereof), and (ii) 50% city resident hiring (measured against the total construction work hours for the project or any phase thereof). The M/WBE Participation Proposal must include a description of the Applicant's proposed outreach plan designed to inform M/WBEs and city residents of job and contracting opportunities. Second, at the time of the Applicant's submission for Part II permit review for the project or any phase thereof, the Applicant must submit to DPD (a) updates (if any) to the Applicant's preliminary outreach plan, (b) a description of the Applicant's outreach efforts and evidence of such outreach, including, without limitation, copies of certified letters to M/WBE contractor associations and the ward office of the alderman in which the project is located and receipts thereof; (c) responses to the Applicant's outreach efforts, and (d) updates (if any) to the applicant's M/WBE and city resident participation goals. Third, prior to issuance of a Certificate of Occupancy for the project or any phase thereof, the Applicant must provide DPD with the actual level of M/WBE and city resident participation in the project or any phase thereof, and evidence of such participation. In addition to the forgoing, DPD may request such additional information as the department determines may be necessary or useful in evaluating the extent to which M/WBEs and city residents are informed of and utilized in planned development projects. All such information will be provided in a form acceptable to the Zoning Administrator. DPD will report the data it collects regarding projected and actual

employment of M/WBEs and city residents in planned development projects twice yearly to the Chicago Plan Commission and annually to the Chicago City Council and the Mayor.

16. This Planned Development shall be governed by Section 17-13-0612. Should this Planned Development ordinance lapse, the Zoning Administrator shall initiate a Zoning Map Amendment to rezone the property to C1-3 Commercial Shopping District.

17. The Applicant acknowledges and agrees that the rezoning of the Property from C1-3 Commercial Shopping District to a C1-3 Commercial Shopping District and then to this Residential-Business Planned Development (PD), triggers the requirements of Section 2-45-115 of the Municipal Code of Chicago (Affordable Requirements Ordinance or ARO). Any developer of a “residential housing project” within the meaning of the ARO must: (i) set aside 10% of the housing units in the residential housing project (Required Units) as affordable units; (ii) pay a fee in lieu of the development of the Required Units; or, (iii) any combination of (i) and (ii); provided, however, that residential housing projects with 20 or more units must provide at least 25% of the Required Units on-site. The Property is located in a low-moderate income area, within the meaning of the ARO, and the project includes two (2) phases, of which the Phase I building includes a total of 59 dwelling units (“Phase I Building”) and the Phase II building has a total of forty-four (44) units (“Phase II Building”) for an overall project total of 108 dwelling units. As a result, the Applicant’s affordable housing obligation is 6 dwelling units for Phase I Building and 4 dwelling units for Phase II Building (10%). Two (2) Phase I Building dwelling units and one (1) Phase II Building dwelling units are Required Units, respectfully for each building (25%). Applicant has agreed to satisfy its affordable housing obligation by providing TBD affordable rental units the Phase I and Phase II Buildings to be constructed in the PD, as set forth in the Affordable Housing Profile Form attached hereto as Exhibit TBD. The Applicant agrees that the affordable rental units must be affordable to households earning no more than TBD of the Chicago Primary Metropolitan Statistical Area Median Income (AMI), as updated annually by the City of Chicago. If the Applicant subsequently reduces (or increases) the number of housing units in the PD, the Applicant shall update and resubmit the Affordable Housing Profile Form to DPD for review and approval; DPD may adjust the number of required Affordable Units without amending the PD. Prior to the issuance of any building permits for any residential building in the PD, including, without limitation, excavation or foundation permits, the Applicant must make the required Cash Payment and/or execute and record an affordable housing agreement in accordance with Section 2-45-115(L). The terms of the affordable housing agreement and any amendments thereto are incorporated herein by this reference. The Applicant acknowledges and agrees that the affordable housing agreement will be recorded against the PD, or the applicable portion thereof, and will constitute a lien against such property. The Commissioner of DPD may enforce remedies for any breach of this Statement 17, including any breach of any affordable housing agreement, and enter into settlement agreements with respect to any such breach, subject to the approval of the Corporation Counsel, without amending the PD.

Notwithstanding the foregoing, if the Applicant receives Low-Income Housing Tax Credits, tax increment financing or other financial assistance whose affordability requirements exceed those of the Affordable Housing Ordinance from the City to develop affordable housing in any portion of the Planned Development (PD), the regulatory, redevelopment, loan or other agreement(s) to be executed by the City and the Applicant in connection with such tax credits or other financial assistance shall govern and control the Applicant's obligation to provide affordable housing for such subsidized portion of the PD.

18. Prior to the Part II Approval (Section 17-13-0610 of the Chicago Zoning Ordinance) in Sub-Area B, the Applicant shall submit a site plan, landscape plan and building elevations for the specific Sub-Area(s) for review and approval by the Department of Planning and Development (DPD). Review and approval by DPD is intended to assure that specific development components substantially conform with the Planned Development (PD) and to assist the City in monitoring ongoing development. Sub-Area Site Plan Approval Submittals (Section 17-13-0800) need only include that portion of the Property for which approval is being sought by the Applicant. If the Applicant is seeking approval for a portion of the Property that represents less than an entire Sub-Area, the Applicant shall also include a site plan for that area of the Property which is bounded on all sides by either public Rights-of-Way or the boundary of the nearest Sub-Area. The site plan provided shall include all dimensioned and planned street Rights-of-Way.

No Part II Approval for any portion of the Property shall be granted until Site Plan approval has been granted. Following approval by DPD, the approved Sub-Area Site Plan Approval Submittals, supporting data and materials shall be made part of the main file and shall be deemed to be an integral part of the PD.
