BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-3 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 1-J in the area bounded by

The public alley next north of West Lake Street; a line 125 feet east of the east line of North St. Louis Avenue as measured along the north line of West Lake Street; West Lake Street; a line 50 feet east of the east line of North St. Louis Avenue as measured along the north line of West Lake Street

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and due publication.

## Narrative and Plans

### Type 1 Zoning Narrative for 3450 West Lake Street M1-3 to B2-3

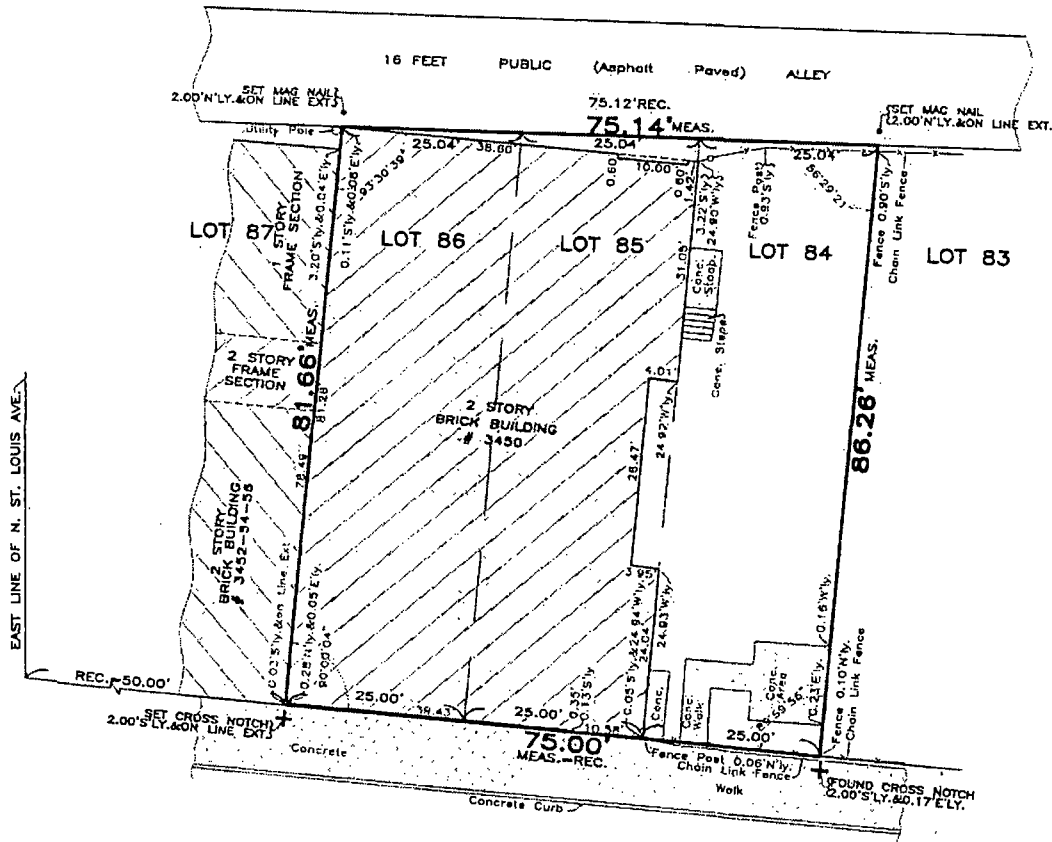

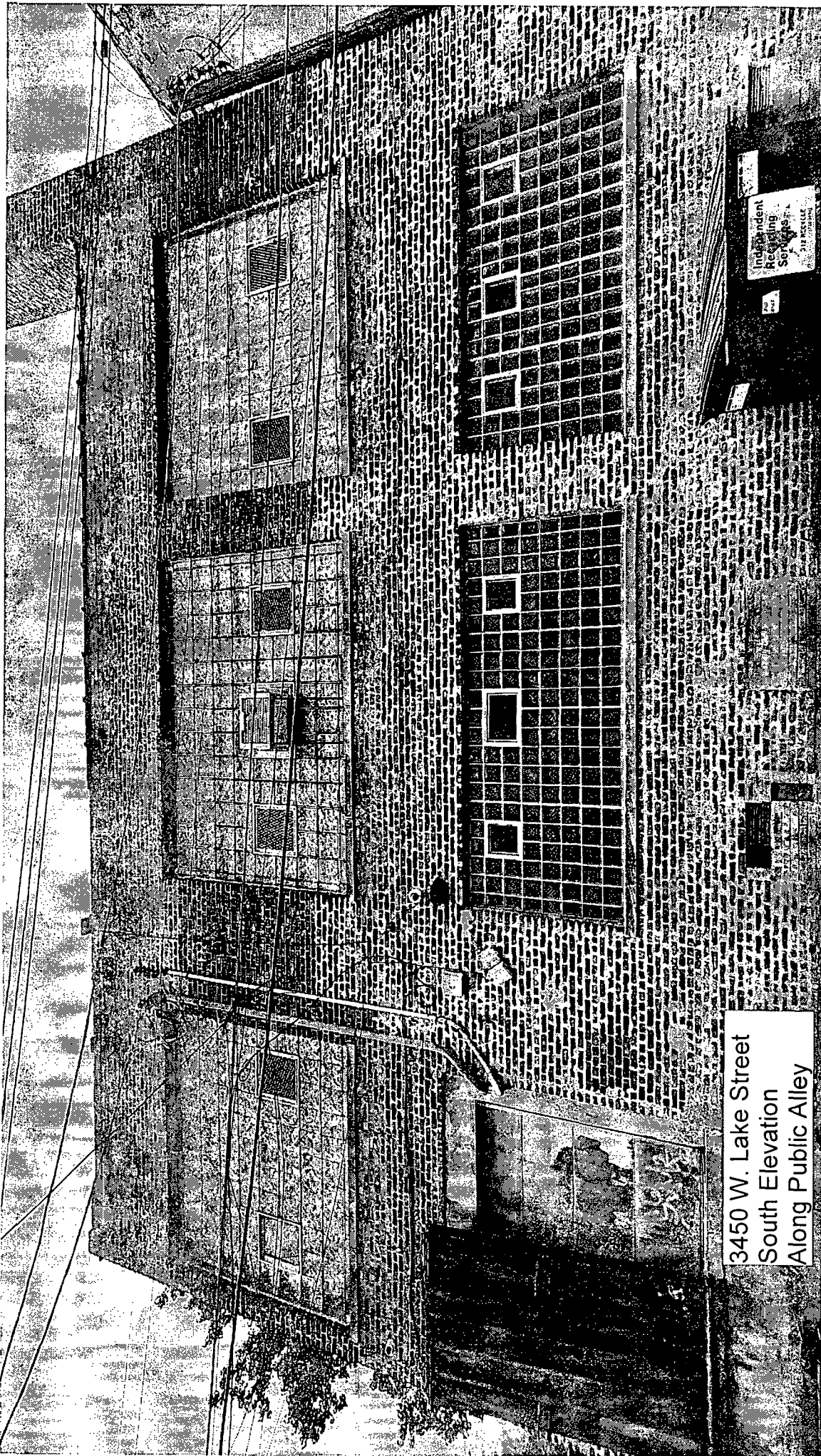
