**A line 25 feet North of and parallel to West 31<sup>st</sup> Street; the public alley next East of and parallel to South St. Louis Avenue; West 31<sup>st</sup> Street; South St. Louis Avenue.**

**To those of a B2-2, Neighborhood Mixed-Use District**
