ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by

North Milwaukee Avenue; a southwesterly perpendicular line to North Milwaukee Avenue 47.90 feet northwest of the northwest boundary line of North Wood Street (as measured along the southwest boundary line of North Milwaukee Avenue); the public alley next southwest of and parallel to North Milwaukee Avenue; a southwesterly perpendicular line to North Milwaukee Avenue 73.03 feet northwest of the northwest boundary line of North Wood Street (as measured along the southwest boundary line of North Milwaukee Avenue),

to those of a C1-2 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.

In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 30, 2012, I, the undersigned, will file an application for a change in zoning from a B3-2 Community Shopping District to a C1-2 Neighborhood Commercial District on behalf of the Golin Family Trust, owner of the property located at 1366 North Milwaukee Avenue.


The applicant seeks a zoning amendment to a C1-2 Neighborhood Commercial District in order to allow a tavern which is within 400 feet of an existing tavern. A previous rezoning of this location in July 2011 from B1-2 to B3-2 and a Special Use for a Tavern have been granted; however, the Department of Business Affairs & Consumer Protection will not grant a tavern license in a B3 zone within 400 feet of an existing tavern.

The applicant intends to use the subject property to allow an existing 1-story building of approximately 3000 square feet, currently vacant, to be built out as a Tavern and as a Public Place of Amusement with arcade games. No additional changes will be made to the existing space or the building height. Currently there is no parking.

The applicant/property owner is: Golin Family Trust, 3920 North Lake Shore Drive, Chicago, Illinois 60613. Barry Golin is trustee and beneficiary, and Howard Golin is beneficiary.

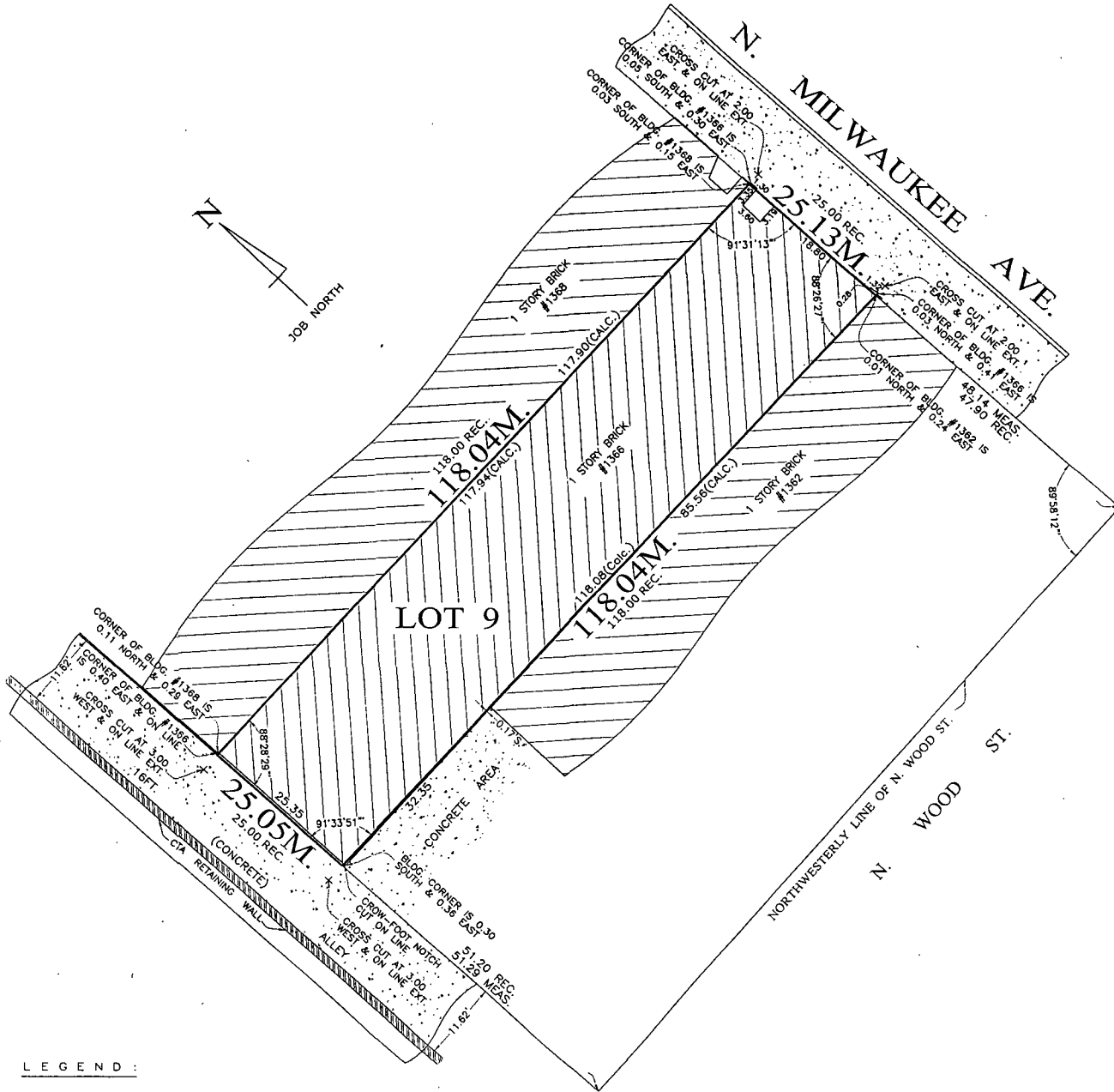
