

**BE IT ORDAINED BY THE CITY COUNCIL OF CHICAGO:**

**SECTION 1.** Section 10-20-430 of the Municipal Code of Chicago, the Commissioner of Transportation is hereby authorized and directed to exempt **Mex Flavor / Ernesto Hernandez of 4753 South Talman Avenue**, from the provisions requiring barriers as a prerequisite to prohibit alley ingress and egress to parking facilities for premise address.

**SECTION 2.** This ordinance shall take effect and be in force from and after its passage and publication.
