ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current RT4 Residential Two-flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 6-I in the area bounded by:

West 25th Street; a line 169.00 feet west of and parallel to South California Avenue; the alley next south of and parallel to West 25th Street; and a line 193.00 feet west of and parallel to South California Avenue

to those of a RM5 Residential Multi-Unit District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

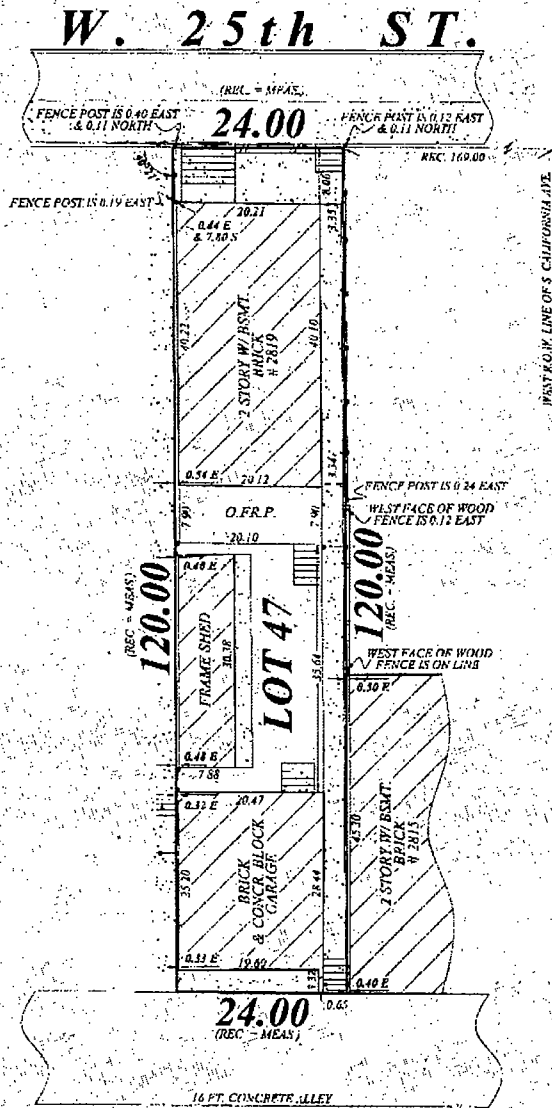
