Be It Ordained by the City Council of the City of Chicago.

SECTION 1. Permission and authority are hereby given and granted to MARGIE'S CANDIES, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, ten (10) Occupation of Space(s) (Chairs on the public way Not for sidewalk café use) on the public right-of-way adjacent to its premises known as 1960 N. Western Ave.

Said Occupation of Space(s) at N. WESTERN measure(s):
Ten (10) at twenty-five (25) feet in length, and two (2) feet in width for a total of five hundred (500) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).


This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1132429 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date



